A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA DIRECTING STAFF TO SUBMIT A GRANT APPLICATION TO THE CALIFORNIA DIVISION OF BOATING AND WATERWAYS FOR BOAT LAUNCHING FACILITY GRANTS FOR MOTORIZED BOATS AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE APPLICATIONS, CONTRACTS, AGREEMENTS, AND AMENDMENTS NECESSARY TO IMPLEMENT THE GRANT

WHEREAS, the California Division of Boating and Waterways ("DBW") administers the Boat Launching Facilities ("BLF") Grant Program, which provides financial assistance for the design, permitting, and construction of public boat launch facilities; and

WHEREAS, the City of Redondo Beach ("City") has the authority to construct, operate, and maintain a boat launch facility within King Harbor; and

WHEREAS, the City desires to enhance King Harbor to better serve motorized watercraft users and to improve public amenities associated with the boat launch facility; and

WHEREAS, the City intends to apply to DBW for BLF grant funding to support the design, permitting, and construction of a new or improved boat launch facility in King Harbor.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Redondo Beach hereby:

SECTION 1. The City Council of the City of Redondo Beach hereby directs City staff to prepare and submit a grant application package to the California Division of Boating and Waterways for Boat Launching Facility funding, pursuant to the provisions of the Harbor and Watercraft Revolving Fund and the BLF Grant Program guidelines, substantially in the form attached hereto as Exhibit "A."

SECTION 2. The City Council of the City of Redondo Beach authorizes the City Manager, or designee, to execute, on behalf of the City, all necessary applications, contracts, agreements, amendments, and other documents required to implement and administer the grant and any projects approved through the BLF program.

SECTION 3. This resolution shall take effect immediately upon its adoption by the City Council.

SECTION 4. The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.
