

THIRD AMENDMENT TO THE AGREEMENT FOR ANIMAL LICENSING SERVICES

THIS THIRD AMENDMENT TO THE AGREEMENT FOR ANIMAL LICENSING SERVICES ("Third Amendment") is entered into by and between the City of Redondo Beach, a chartered municipal corporation ("City"), and PETDATA, INC., a Texas for-profit corporation ("Contractor"), effective as of August 18, 2026.

WHEREAS, the parties hereto entered into that certain Agreement for Animal Licensing Services, effective January 19, 2021 ("Agreement");

WHEREAS, on January 13, 2026, the parties hereto entered into the First Amendment to the Agreement ("First Amendment") to extend the term of the Agreement for an additional six (6) months, covering Months 61 through 66, under the same pricing and compensation structure then in effect;

WHEREAS, on July 14, 2026 the parties hereto entered into the Second Amendment to the Agreement ("Second Amendment") to extend the term of the Agreement for an additional one (1) month, covering Month 67, under the same pricing and compensation structure then in effect;

WHEREAS, the Agreement currently expires at the close of business on August 18, 2026; and

WHEREAS, the parties hereto desire to extend the term of the Agreement for an additional two (2) months, covering Months 68 and 69, under the same pricing and compensation structure currently in effect.

NOW THEREFORE, in consideration of the promises and mutual covenants contained herein, and intending to be legally bound, the parties hereto agree to make the following amendments to the Agreement:

1. COMPENSATION TO CONTRACTOR

a. Amendment to Section 6.A (Basic Fees)

Section 6.A (Basic Fees) of the Agreement, as previously amended, is hereby further amended to provide as follows for Months 68 and 69 of the Agreement:

For Months 68 and 69 of the Agreement:

- \$4.30 for each one-year license or replacement tag;
- \$6.30 for each two-year license or replacement tag;
- \$8.30 for each three-year license or replacement tag; and
- \$2.50 collection service fee for each late fee, if any, paid by a Licensee.

All minimum annual and monthly fee provisions, payment terms, fees, cost reimbursements, charges, and related compensation conditions set forth in Section 6 of the Agreement shall continue to apply to this extension; provided, however, that the minimum aggregate annual fee for this two (2) month extension shall be prorated and shall equal One Thousand Dollars (\$1,000) to reflect the two (2) month extension. No Start-Up Fee shall apply to this extension.

2. **TERM.** Section 10 (Term) of the Agreement, as previously amended, is hereby further amended to extend the term of the Agreement for an additional two (2) months, such that the Agreement shall expire at the close of business on October 18, 2026, unless sooner terminated in accordance with the Agreement. This extension constitutes Months 68 and 69 of the Agreement.
3. **NO OTHER AMENDMENTS.** Except as expressly amended herein, the Agreement shall remain unchanged and in full force and effect. The Agreement, First Amendment, Second Amendment, and this Third Amendment constitute the entire agreement between the parties and supersede any previous oral or written agreements with respect to the subject matter hereof. In the event of any inconsistency between the terms of the Agreement, First Amendment, Second Amendment, and this Third Amendment, the terms of this Third Amendment shall govern.
4. **AUTHORITY AND COUNTERPARTS.** Each party represents and warrants that it has the authority to execute this Third Amendment. This Third Amendment may be executed in counterparts and by electronic signature, each of which shall be deemed an original, and all of which together shall constitute one and the same instrument.

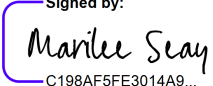

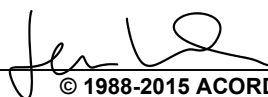
