## **RESOLUTION NO. CC-2510-071**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, AUTHORIZING A FISCAL YEAR 2025-2026 BUDGET MODIFICATION TO APPROPRIATE \$1,747,973 OF PROPOSITION C FUNDS FROM LOS ANGELES COUNTY METROPOLITAN TRANSPORTATION AUTHORITY (LACMTA) TO THE AVIATION BOULEVARD RESURFACING – ARTESIA BOULEVARD TO MANHATTAN BEACH BOULEVARD PROJECT, JOB NO. 41440

WHEREAS, it is the intention of the City Council of the City of Redondo Beach ("City Council") to review the adopted budget from time to time;

WHEREAS, the City of Redondo Beach's adopted budget needs to be modified to appropriate monies to fund necessary expenditures;

WHEREAS, due to a Federal Corrective Action imposed on Los Angeles County in the Fall of 2023, distribution of STPL funds by the Los Angeles County Metropolitan Transportation Authority (Metro) has been put on hold, effectively ending the STPL program;

WHEREAS, on April 16, 2025, the Los Angeles County Metropolitan Transportation Authority Board of Directors authorized local agencies to receive their unprogrammed Surface Transportation Program-Local (STPL) balances through fulfillment agreements for projects that begin on or after that date;

WHEREAS, Metro has awarded the City \$1,747,973 in Proposition C Funds for the Aviation Boulevard Resurfacing – Artesia Boulevard to Manhattan Beach Boulevard Project, Job No. 41440 ("Project"), which is deemed an eligible project by Metro; and

WHEREAS, the City is entering into an STPL Fulfillment Agreement with Metro for the transfer of the \$1,747,973 of STPL funds from the Manhattan Beach Boulevard Resurfacing – Aviation Boulevard to Inglewood Avenue Project, Job No. 41160, to the Project; and

WHEREAS, following approval of the STPL Fulfillment Agreement, the City desires to appropriate these funds to the Project.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The amounts allocated in the Fiscal Year 2025-2030 Five-Year Capital Improvement Program budget and the amounts required to meet conditions which have arisen during the budget year and require a modification in the budget appropriations; and, upon recommendation of the City Manager, the budget appropriation as adopted for Fiscal Year 2025-2026 is modified as follows:

One million seven hundred forty-seven thousand nine hundred seventy-three dollars (\$1,747,973) in Proposition C funds from Metro shall be appropriated to the Intergovernmental Grant Fund account for the Aviation Boulevard Resurfacing – Artesia Boulevard to the Manhattan Beach Boulevard Project, Job No. 41440.

SECTION 2. Pursuant to Section 11(f) of the City Charter, the City Clerk is hereby directed to correct the budget records of said City for Fiscal Year 2025-2026 in accordance with the above modification.

SECTION 3. This resolution shall take effect immediately upon its adoption by the City Council.

SECTION 4. The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.
