A. CALL MEETING TO ORDER

An Adjourned Regular Meeting of the Redondo Beach City Council was called to order at 6:00 p.m. by Mayor Light in the City Hall Council Chambers, 415 Diamond Street, Redondo Beach, California.

C. SALUTE TO THE FLAG AND INVOCATION

Mayor Light led in the salute to the flag and called for a moment of silence.

D. PRESENTATIONS/PROCLAMATIONS/ANNOUNCEMENTS/AB 1234 TRAVEL EXPENSE REPORTS

Councilmember Nehrenheim talked about the recent District 1 community meeting where they discussed RCV and the upcoming election; announced an online community meeting next Wednesday at 6:30 p.m. via Zoom and Facebook.

Councilmember Loewenstein announced the District 2 community meeting will be either January 23rd or the 27th; thanked the First Responders and Fire Department for all the work they have done during the Pacific Palisades fire and the Police Department for keeping the peace in the affected areas.

Councilmember Kaluderovic stated she had a great online District 3 meeting on Saturday; thanked everyone that attended and said they discussed the upcoming election; reported that many residents wanted to know where to get election information and directed them to the Chamber of Commerce; mentioned the NRBBA put together a great opportunity to help the RB firefighters or show appreciation for all they are doing by donating or purchasing gift cards.

Councilmember Obagi echoed what Councilmembers Loewenstein and Kaluderovic said; thanked the community that reached out to try to support the victims, firefighters and police officers; stated his understanding from the SBCCOG is that the non-profits are overwhelmed with donations at this point; suggested monetary donations to the Red Cross and other non-profits supporting this cause.

Councilmember Behrendt and Mayor Light expressed their appreciation to First Responders in keeping everyone safe.
