Background

- General Plan Update – Project Segmented
- City Council Actions - November 5th and 12th
 1. Adopted a resolution certifying the associated Final Program Environmental Impact Report (PEIR)
 2. Adopted three ordinances amending Title 10 Chapters 1, 2 and 5 of the Redondo Beach Municipal Code implementing the City's 6th Cycle Housing Element
 3. Directed staff to return on December 3, 2024, with subsequent environmental impact analysis associated with a 1.25 FAR at the BCHD campus. (Certified PEIR studied 0.85-1.0 FAR)
- Remainder of the General Plan updates are scheduled to be considered in January or February of 2025

Addendum

- Addendum to the certified PEIR, along with a Resolution for adoption, has been prepared for the City Council's consideration
- Analyzes changes to the previously certified PEIR for citywide General Plan Update
- Does not commit the City Council to a future policy decision
- Provides the option of approving up to a 1.25 FAR cap at the BCHD campus as a component of the General Plan - Land Use Element Update in Jan/Feb

- Addendum is adequate unless substantial changes are proposed that would involve new significant environmental effects or a substantial increase in the severity of previously identified significant effects
- Project certified in PEIR vs. “Modified Project”
