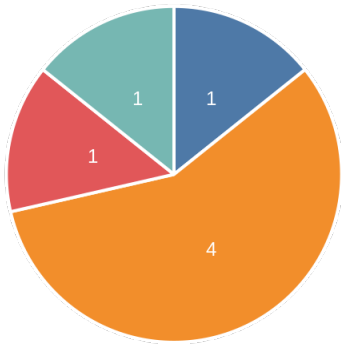

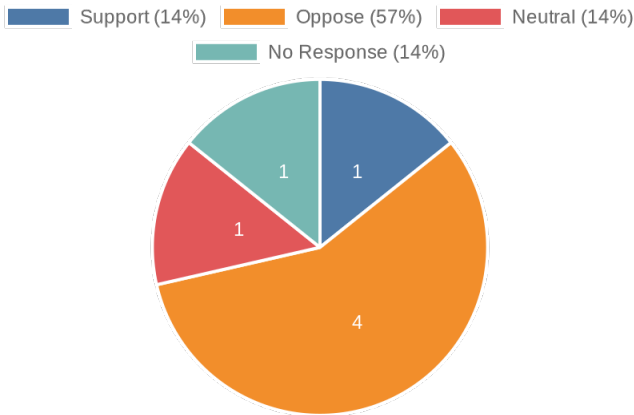

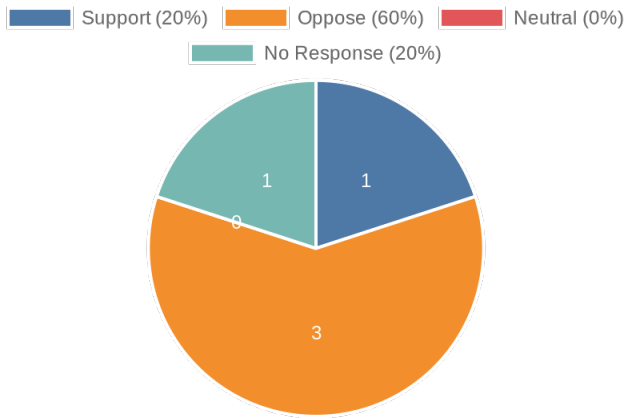

The Council's plan to spot up-zone the BCHD site to 1.25 FAR is misguided. Unlike the City, BCHD provides the majority of its services outside of both Redondo Beach and the District. It is not a public safety entity like the Rbfd and RBPD.

Either ALL P-I should be up-zoned and analyzed at a 1.25 FAR - or - BCHD should remain at the 0.5 FAR or 0.75 FAR or legacy existing 0.77 FAR. The City's preferential treatment will likely result in litigation, as stated in public comments by Mayor Light in the GPAC.

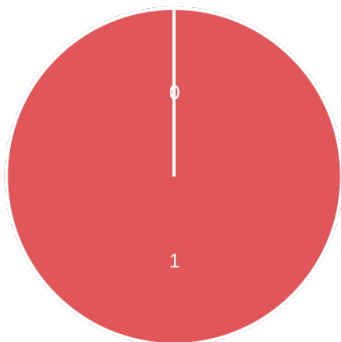

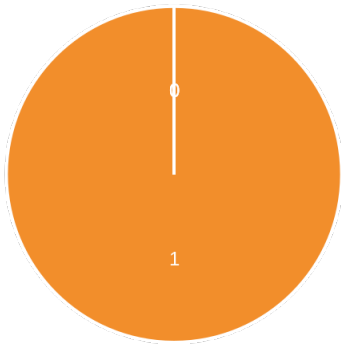
