

**RESOLUTION NO. CC-2508-063**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, AUTHORIZING A FISCAL YEAR 2025-2026 BUDGET MODIFICATION TO ALLOCATE \$25,326 FROM THE CITY OF MANHATTAN BEACH FOR THE BEACH CITIES TRANSIT LINE 109 COST SHARING TO THE TRANSIT FUND**

WHEREAS, it is the intention of the City Council of Redondo Beach ("City Council") to review the adopted budget from time to time;

WHEREAS, the City of Redondo Beach's adopted budget needs to be modified to allocate monies from outside sources to fund necessary expenditures;

WHEREAS, on July 1, 2025, the City of Redondo Beach ("City") and the City of Manhattan Beach entered into a Transit Service Operations Agreement to provide Beach Cities Transit ("BCT") Line 109 service throughout the City of Manhattan Beach;

WHEREAS, pursuant to this agreement, the City of Manhattan Beach will contribute \$25,326 to the City to support BCT Line 109 operations throughout the City of Manhattan Beach;

WHEREAS, since the adoption of the budget, additional, previously unbudgeted revenue has been identified, which must be allocated to the Transit Fund to support bus operations for the BCT Line 109; and

WHEREAS, the revenue to be received from the City of Manhattan Beach is not included in the adopted Fiscal Year 2025-2026 Budget, and a budget modification is necessary to allocate these funds to the Transit Fund.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The amounts allocated in the Fiscal Year 2025-2026 Budget need to be modified to recognize additional revenue received during the budget year; and, upon recommendation of the City Manager, the budget as adopted for Fiscal Year 2025-2026 is modified as follows:

Twenty-five thousand and three-hundred twenty-six dollars (\$25,326) shall be allocated to the Transit Fund.

SECTION 2. Pursuant to Section 11(f) of the City Charter, the City Clerk is hereby directed to correct the budget records of said City for Fiscal Year 2025-2026 in accordance with the above modification.

SECTION 3. This Resolution shall take effect immediately upon its adoption by the City Council.

SECTION 4. The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.
