

RESOLUTION NO. CC-2602-006

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, ADOPTING A MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF REDONDO BEACH AND THE REDONDO BEACH POLICE OFFICERS' ASSOCIATION FROM JANUARY 1, 2026 THROUGH DECEMBER 31, 2026

WHEREAS, pursuant to Chapter 10 (section 3500 et seq.) of Division 4, Title 1 of the Government Code and Resolution No. 6046, Resolution for Administration of Employer-Employee Relations, the matters within the scope of representation that are set forth in the attached Memorandum of Understanding ("MOU") have been discussed by and between representatives of the City of Redondo Beach ("City") and representatives of the Redondo Beach Police Officers' Association ("RBPOA"), and except as otherwise specifically provided herein, shall apply only to those employees who are employed full-time and are appointed to permanent positions in the RBPOA Bargaining Unit; and,

WHEREAS, the existing MOU with the RBPOA expired on December 31, 2025; and,

WHEREAS, representatives of the City and the RBPOA have met and conferred in good faith and have reached agreement on a successor MOU; and,

WHEREAS, the attached MOU will provide adjustments agreed upon by the RBPOA; and,

WHEREAS, said MOU is not binding until presented to the Mayor and City Council for approval.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. That the MOU, attached hereto as Exhibit "A" and made a part hereof, between the City and RBPOA for the period beginning January 1, 2026 and ending December 31, 2026 is hereby adopted.

SECTION 2. The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.
