FIRST AMENDMENT TO THE AGREEMENT FOR PROJECT SERVICES BETWEEN THE CITY OF REDONDO BEACH AND MACKAY METERS, INC.

THIS FIRST AMENDMENT TO THE AGREEMENT FOR PROJECT SERVICES ("First Amendment") is made between the City of Redondo Beach, a Chartered Municipal Corporation ("City") and MacKay Meters, Inc. a Florida corporation, whose corporate headquarters is located at 1342 Abercrombie Road, New Glasgow, Nova Scotia, Canada B2H 5C6 (hereinafter called "MacKay" or "Contractor").

WHEREAS, on April 21, 2020, the parties originally entered into the Agreement for Project Services between the City and Consultant (the "Agreement"); and

WHEREAS, the volume of products to be purchased has been determined to exceed that originally anticipated when the Agreement was executed; and

WHEREAS, therefore, the parties desire to amend Exhibit "A" to reflect the purchase of the MacKay Tango, an additional product; and

WHEREAS, the parties desire to increase Contractor's total compensation by executing Exhibit "C-1"; and

WHEREAS, the parties seek to correspondingly extend the term of the Agreement.

NOW THEREFORE, in consideration of the promises and mutual covenants contained herein, and intending to be legally bound, the parties hereby agree to make the following amendment to the Agreement:

- 1. SCOPE. Exhibit "A" of the Agreement is hereby amended to add the MacKay Tango multi-space parking pay station. It shall be inserted after the mkBeacon section on page 10. Exhibit "A" of the Agreement shall reflect this change made pursuant to the execution of this First Amendment. The remaining provisions of Exhibit "A" shall remain unchanged and in full force and effect.
- TERM. Exhibit "B" of the Agreement is hereby amended to amend the term of the Agreement to not expire until November 15, 2023. Exhibit "B" is further amended to allow three (3), two-year (2-year) extensions by written agreement of the parties. This First Amendment shall reflect Exhibit "B-1" which is attached hereto and incorporated by reference.
- COMPENSATION. Exhibit "C" of the Agreement is hereby amended to add Exhibit "C-1", which shall increase the limit for the total compensation paid to Contractor.

Exhibit "C-1" is attached hereto and incorporated by reference. Contractor shall be compensated for the services described in Exhibit "A" of the Agreement in accordance with Exhibit "C-1". The remaining provisions of Exhibit "C" shall remain unchanged and in full force and effect.

4. NO OTHER AMENDMENTS. Except as expressly stated herein, the Agreement shall remain unchanged and in full force and effect. The Agreement and this First Amendment constitute the entire agreement between the parties and supersede any previous oral or written agreement with respect to the subject matter hereof. In the event of any inconsistency between the terms of the Agreement, and this First Amendment, the terms of this First Amendment shall prevail.

Hosted Remote Monitoring and Notification Service for MacKay mkBeacon™ Including Credit Card Payment Gateway and Cellular Communications

MacKay will supply a hosted system for performing parking management functions. The Parking Management System will include:

- Sentinel™ MMS, used to remotely monitor the on-street status of the mkBeacon or mkBeacon dual space or Tango operations and notify the City of any alerts. Also, Sentinel can generate a variety of reports on the information downloaded periodically each day from the mkBeacon or mkBeacon dual space or Tango over the wireless Cellular network.
- Cellular communications for each meter that allow for data to flow to Sentinel™ MMS or for credit card authorizations through CreditCall Ltd.
- · Credit card transaction fees
