





It is unclear if electric leaf blowers are "better" than gas powered. I don't see enough evidence to make a determination and instead, I'd recommend aggressive enforcement of all leaf blowers while staff work is

completed.

#### No GHG Calculations in Evidence

Electric may generate fewer GHGs, although for battery powered units, that is a supposition not yet in evidence. Battery chargers are relatively inefficient and generate heat. Batteries lose charge. And the time of day of charging could range from very low GHG on the margin to full natural gas on the margin or possibly out of state imports that include coal.

#### No Comprehensive Noise Testing


I own gas powered, corded electric and battery tools, including leaf blowers, string trimmers, mulching vacuums, chainsaws, etc. I cannot with any certainty state that the full spectrum of noise testing has been completed to determine if electric is more or less noisy or health damaging to hearing than gas powered.

#### No Toxic Air Emissions Such as PMx Calculations in the Record

Most particulate matter comes from the blowing, not the combustion. For example, a gas powered car and an equivalent EV both generate the same amount of PMx in the form of dust particles when driving down a gravel road.


##### Virtual Earth Day, April 19th
