### Access Schedule:

Host has agreed to grant exclusive access to the designated space for the following dates:

<b>May 23, 2026</b>	<b>June 2, 2026</b>

During the above period, RR/CC staff shall have vehicle access to the designated space from 6:00pm – approximately 10:00pm. On Election Day, June 2, 2026, RR/CC staff shall have vehicle access to the designated space from 6:00pm – approximately 12:00am.

## **Designated Space, Parking, and Public Access**

Host will provide RR/CC with access to five (5) continuous parking stalls to set up a Check-In Center. This space will accommodate one (1) supply van and the tables and equipment needed by the RR/CC.

Host will permit Election Workers access to Check-In-Center during the designated dates and hours. Election Workers will drive up to a Check-In-Center where staff will retrieve voted ballots and other election materials.

RR/CC shall limit signage and vehicle traffic to the mutually agreed upon areas.

RR/CC staff will arrive on site at 3:00 PM on May 24, 2026, to reserve five (5) parking stalls to ensure area is secure for operational purposes.

## **Amendment of the Agreement**

No alteration or variation of the terms of this agreement shall be valid unless made in writing and signed by both parties. This agreement may be modified or amended only upon a subsequent amendment executed by both Host and the RR/CC.

**Indemnity Agreement:** Host will indemnify, defend and hold harmless RR/CC, its trustees, elected and appointed officers, agents, employees, and volunteers from and against any and all liability, including, but not limited to, claims for injury or damages, demands, actions, fees, loss, costs and expenses (including reasonable attorney and expert witness fees) arising out of or incurred in connection with the performance of this agreement, but only in proportion to and to the extent such liability, loss demands, actions, fees, costs and expenses are caused by or result from the grossly negligent or willful misconduct of the Host, its officials, officers, agents, employees, or volunteers.

RR/CC shall indemnify, defend and hold harmless Host, its officials, officers, agents, employees, independent contractors and volunteers from and against any and all liability, including, but not limited to, claims for injury or damages, demands, actions, fees, loss, costs and expenses (including reasonable attorney and expert witness fees) arising out of or incurred in connection with the performance of this agreement, but only in proportion to the extent such liability, loss, demands, actions, fees, costs and expenses are caused by or result from the negligent or intentional acts or omissions of the RR/CC, its trustees, officers, agents, employees, or volunteers.

Notwithstanding the foregoing, RR/CC acknowledges and understands that certain parties will have access to the designated space, including but not limited to, custodial contractors and emergency staff. In no event shall Host be liable for any access to the designated facility space by these parties.

**Additional Access Considerations**

The following details represent any additional considerations necessary in providing RR/CC access to the designated space (Alarm Codes, Gate keys, Access Badges, Parking Passes, etc.):

APPLIES TO 5 PARKING SPACES ONLY WITHIN THE CROSS-HATCHED SECTION MARKED ON EXHIBIT MAP ATTACHED

**Electronic Signatures:** The Host and RR/CC agree to facsimile and electronic scanned versions of original signatures of authorized signatures of each party have the same force and effect as original signatures such that the parties need not follow up facsimile or electronic transmissions of executed documents with original wet-signature versions.

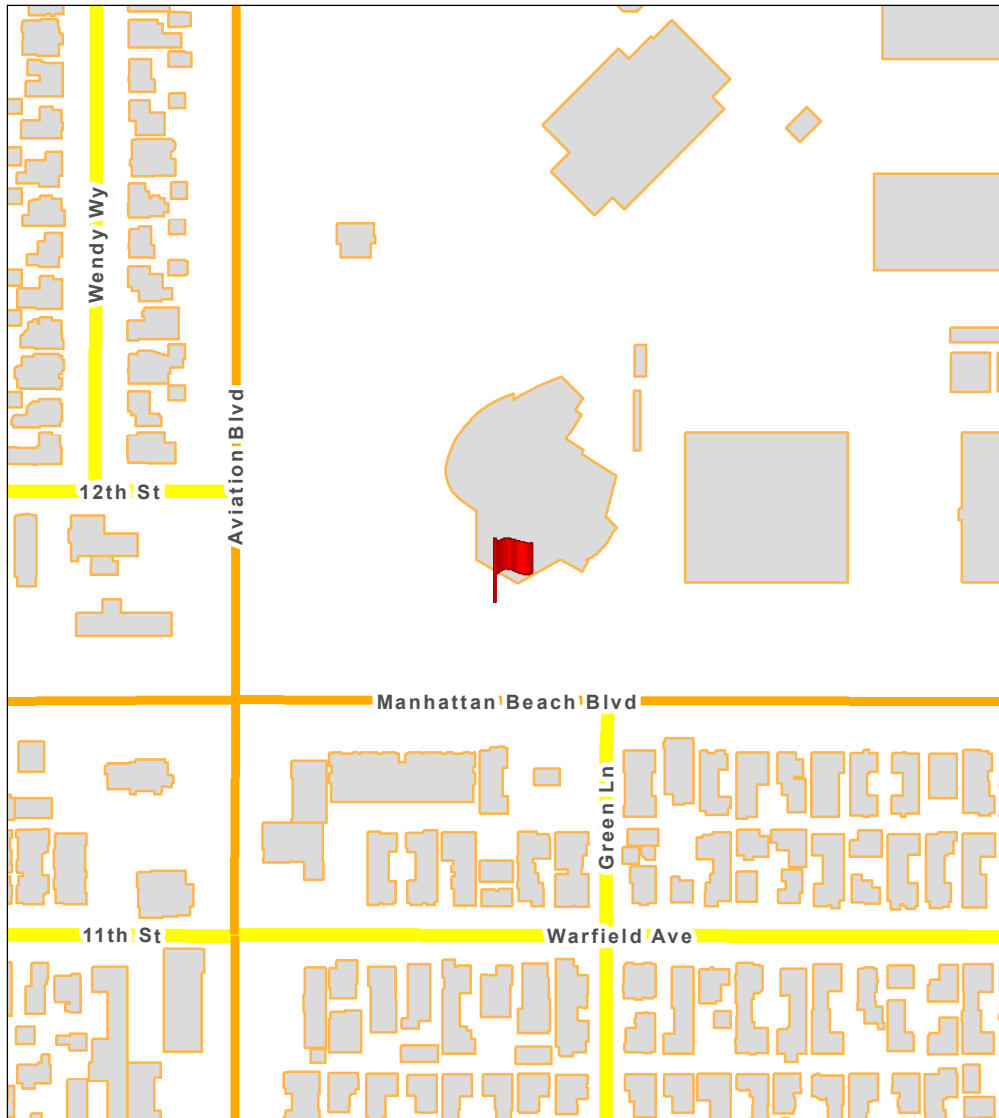
