BCHD indebted District taxpayers to a \$172M off-balance-sheet debt when it wanted to get \$6.3M from the State to build a shiny new allcove building. How did BCHD do that? BCHD agreed to provide allcove for a minimum of 30 years to all 12-25 year-olds in the LA County SPA8, 1.4M population area. The 30-year cost is estimated at \$172M and only 9% of the service area is District taxpayers.

Vote No on Measure BC to stop the \$172M District taxpayer debt. BCHD underestimated the allcove building cost by \$9M. If BCHD is denied the Measure BC funding, then BCHD can't build the allcove building and the 30-year obligation to service all of LA County SPA8 ends. The allcove program for District residents can continue as needed for a small fraction of the \$172M cost. Off balance sheet debt is how Enron built its house of cards. Stop Measure BC and stop BCHD from being required to provide allcove for 30 years to LA County on the backs of District taxpayers.

Analysis of BCHD's allcove Beach Cities Equity Performance and Funding Contract Adherence for LA County Service Planning Area 8

Background

- In cooperation with the Los Angeles County Department of Public Health and its Enhanced Community Health (LACDPH) Profiles, StopBCHD's experts have analyzed the impacts of Household (HH) Income on health outcomes
- The basic methodology followed the BCHD District taxpayer-funded, Gallup methodology of valuing incremental differences in obesity levels, diabetes rates, and smoking rates
- The data drew significantly from the LACDPH profiles, US Census Data, BCHD press releases, BCHD Public Records Act responses, Gallup's press release regarding BCHD's unknown, but "likely, in part" contribution to health outcomes in the BCHD beach cities, BCHD budget projections, Building Owners and Manager's data, and BCHD's Measure BC funding request.

Summary Findings

- Changes in SPA8 health outcomes are greatly explained by changes in SPA8 HH income levels
- BCHD participation showed no statistically significant impact on health outcomes of the BCHD beach cities
- The BCHD allcove Beach Cities BCHCIP construction grant was focused on service to Priority Populations (LA County SPA8), required 30-years minimum operation and asset encumbrance of building and services, and provided no long term operational funding
- The amount of the allcove BHCIP construction grant is not too exceed \$6,336,702
- The estimated liability to the District of 30-years allcove operation for LA SPA8 is \$172M
- BCHD allcove Beach Cities enrollment is heavily skewed toward: the District cities, SPA8's higher income areas, SPA8's lower non-white areas, SPA8's areas without mental HPSAs and disadvantaged communities

Statistical Analysis Demonstrates that Health Outcomes Differences in SPA8 are Largely Explained by Income Differences

BCHD issued a \$400,000+ taxpayer-funded contract to Gallup for surveys and analysis. As the funders of the research that BCHD and Gallup have provided into the public via press releases, we are replicating the methodology.

First off, Gallup and BCHD plastered the BCHD logo on the survey, therefore introducing client bias. After all, who wants to say “yes dear interviewer, I’m a fat slob, have diabetes, and smoke 2 packs a day” to the Health District that sent them a letter and survey to their home address. Instead of Gallup’s BCHD-purchased data, we used LA County Department of Public Health data along with CDC data. Client bias is well understood and client names are often withheld.

We recomputed Gallup’s “fictional” health cost savings for all the Cities in LA County SPA8 that had available data. Our findings were very, very clear – HIGH INCOMES = GOOD HEALTH OUTCOMES. In fact, the correlation between income and health outcomes is only 7.3% from being PERFECTLY RELATED.

Unlike Gallup that won’t reveal its sources and data, ours is 100% transparent below.

The statistical regression test below demonstrates that:

- 1) HH Income and Health Outcomes (as measured by the “Gallup Savings”) have a 92.7% correlation.
- 2) 86.0% of the changes in Health Outcomes are explained by changes in HH Income levels.

Statistical Analysis Demonstrates that BCHD had no Statically Valid Impact on Health Outcome Differences in the BCHD Cities

Utilizing Gallup’s monetization of health outcomes method, LA County and Census Data, we conducted a regression analysis to test the relationship between health outcomes and HH income. The regression showed high statistical significance and a 92.7% correlation between health outcomes and HH income along with an R-square of 86%, demonstrating a high level of explanatory power between changes in health outcomes and changes in income levels.

We used a regression model of the form $GallupSavings=f(HHIncome, BCHD Dummy)$
 Gallup’s Savings is a monetization of health outcomes using unnamed Gallup research.

The full results of the model are published below. That findings are as follows:

- 1) The model has good explanatory ability, with an R-square of 86.4%
- 2) HH Income is positively related to the GallupSavings and highly significant
- 3) The BCHD Dummy is negative, indicating that being a BCHD city diminishes health outcomes as measured by the GallupSavings. However, the BCHD Dummy is not significant, so we conclude BCHD simply has NO IMPACT on health outcomes.

This Program Funding Agreement (the "Agreement") is entered into as of May 13, 2023 (the "Effective Date") by and between **ADVOCATES FOR HUMAN POTENTIAL, INC.**, a Massachusetts corporation, with offices located at 490-B Boston Post Road, Sudbury, MA 01776 ("AHP"), and **Beach Cities Health District, formerly known as South Bay Hospital District, a governmental agency with offices at 514 N. Prospect Avenue, Redondo Beach, CA 90277-3970 ("Beach Cities Health District, formerly known as South Bay Hospital District, a governmental agency" or the "Sponsor").** AHP and the Sponsor may be referred to separately as a "Party" or collectively as "Parties."

-Priority populations to be served are youth between the ages of 12-25 from Service-Planning Area 8, including 16 cities and communities of the city of Los Angeles. This population will receive mental and physical health resources, education and employment counseling, peer and family support, and substance use prevention program. Service-Planning Area 8, in the 16 cities and communities of the City of Los Angeles, includes more than 1,000,000 people. Allcove Beach Cities will be able to provide services to those 12-25 years old, including 49% Latino population, followed by 26% white, 15% Asian, 8% African American and 2% other.

BHCIP, DHCS awards competitive grants to qualified entities to construct, acquire, and rehabilitate real estate assets to build new capacity or expand existing capacity for facilities that will operate for a minimum of thirty (30) years to provide short-term crisis stabilization, acute and subacute care, crisis residential, community-based mental health residential, substance use disorder residential, community-based and outpatient behavioral health services, and other

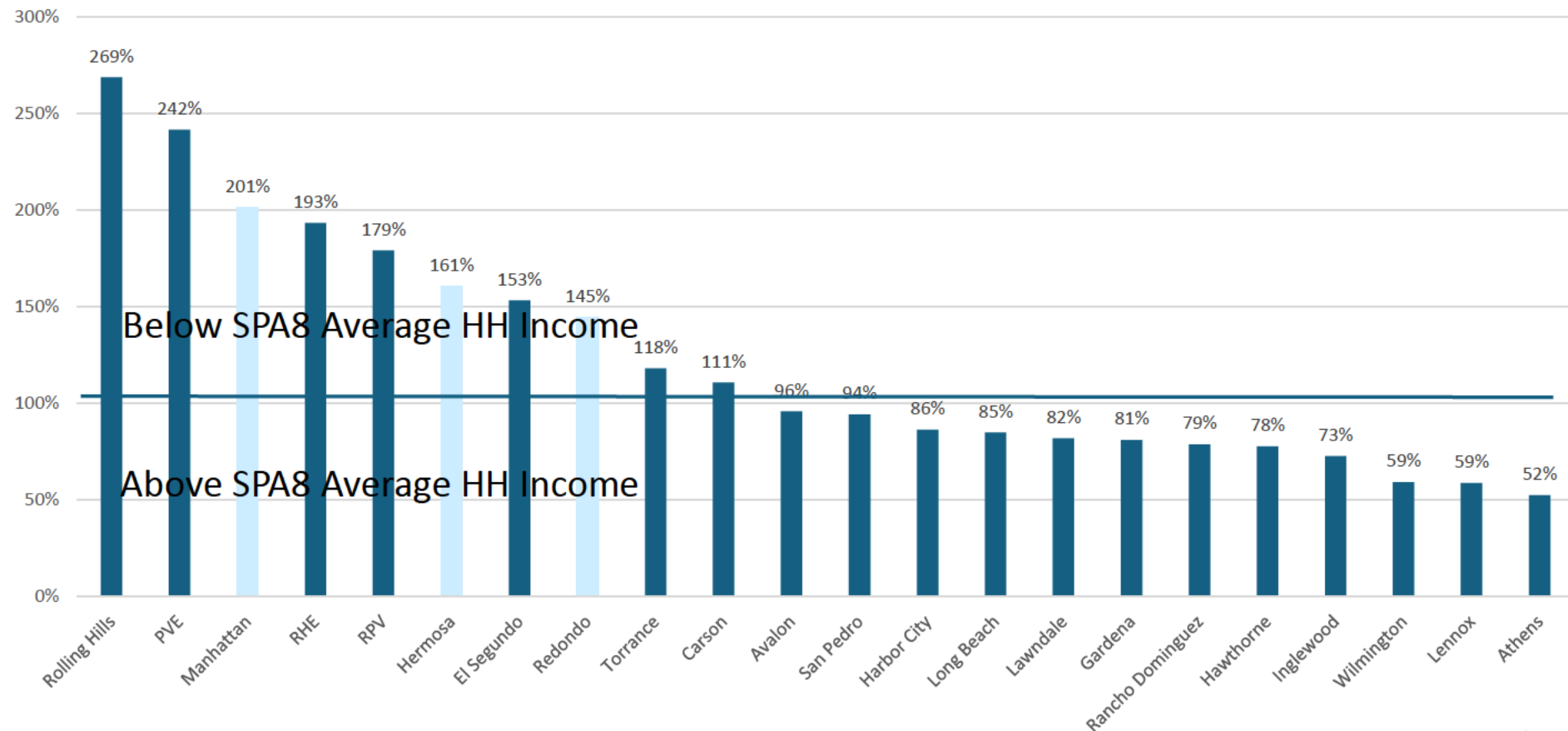

BCHD Cities HH Income is 145% to 201% of SPA8 Average



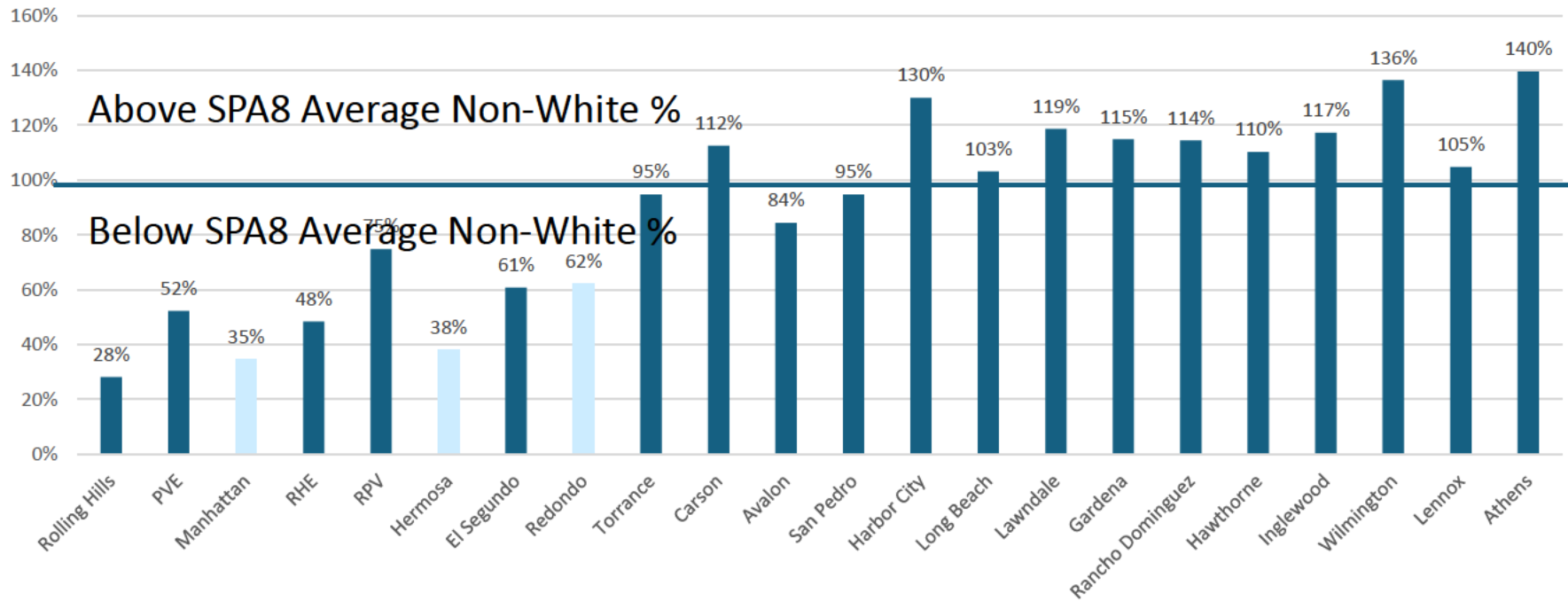
Cities in order of declining HH income, BCHD Cities 145% to 201% of SPA8 average

BCHD Cities non-White Population Share 35% to 62% of SPA8 Average



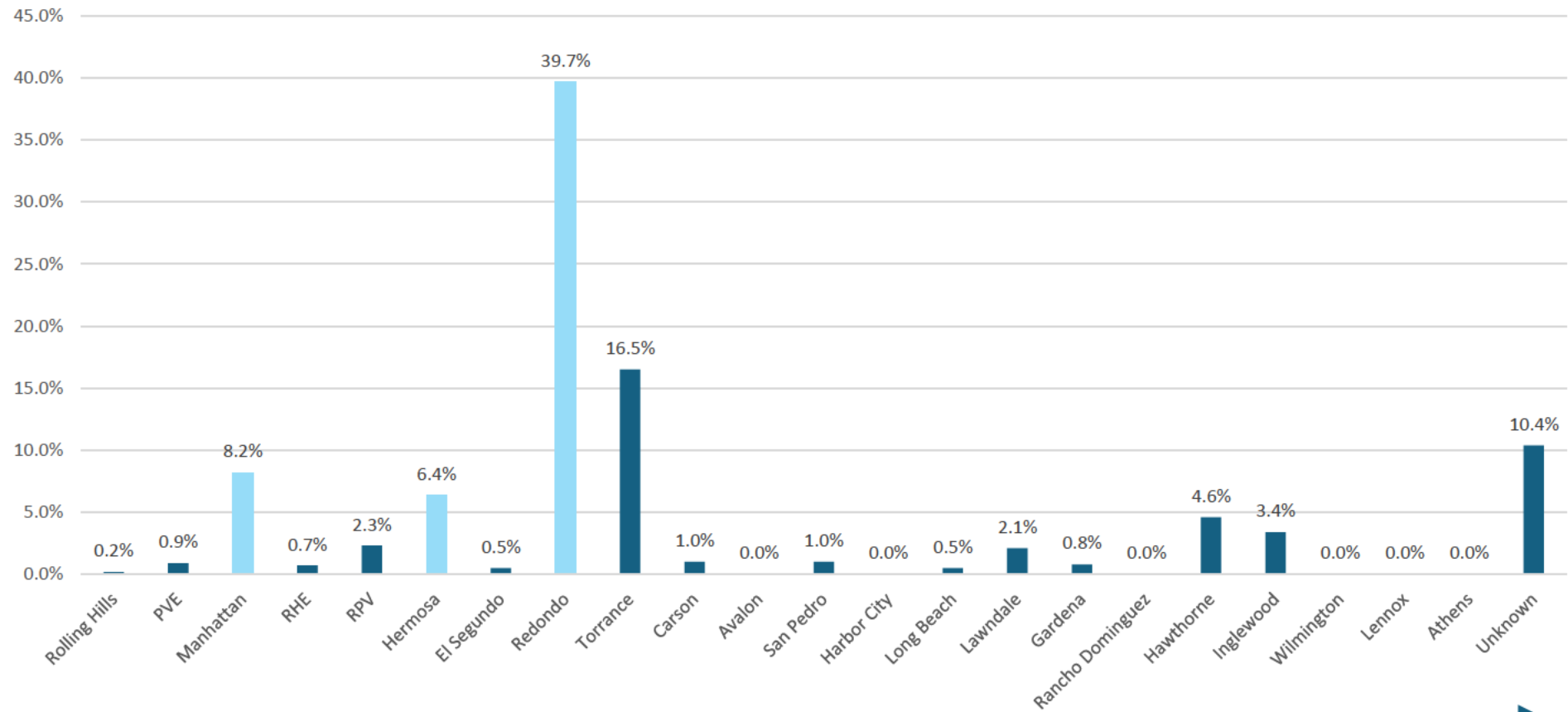

BCHD Cities are 8.7% of SPA8 Population, Majority of allcove Enrollment



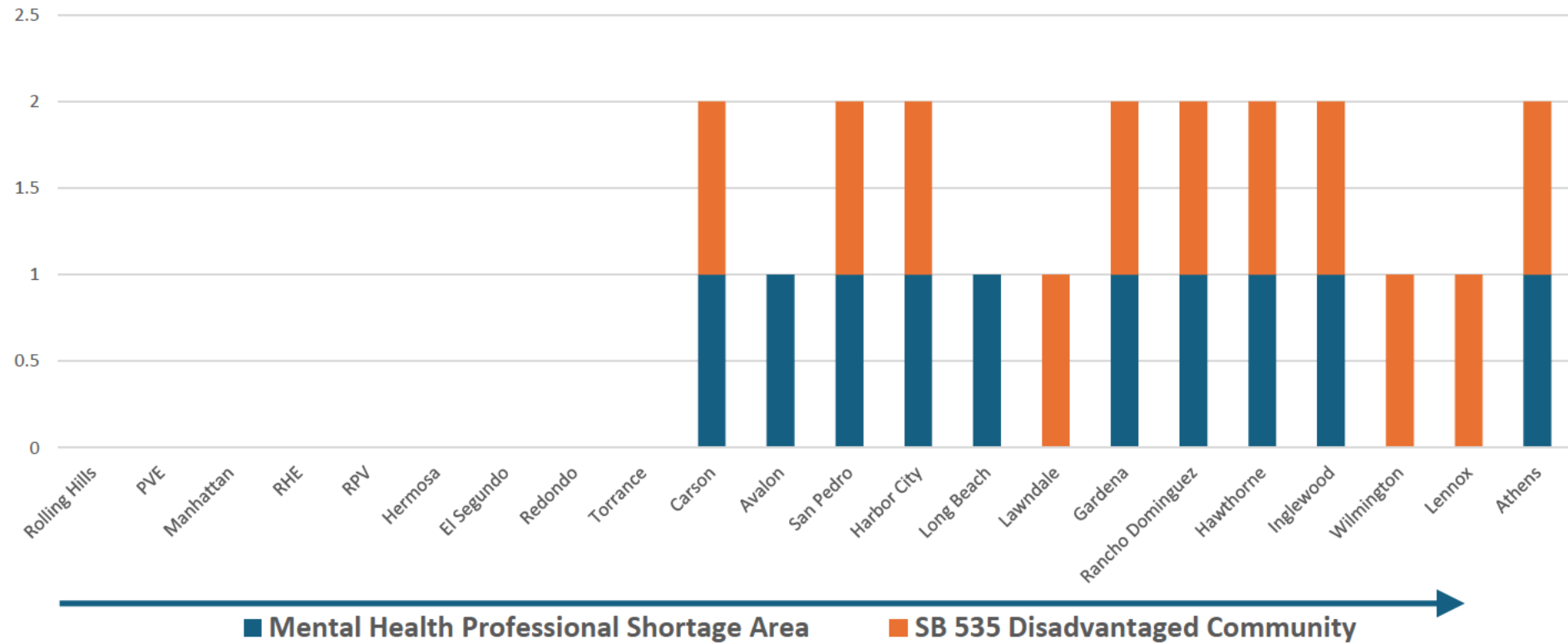

- No long term, 30-year funding was provided. Is a lopsided \$172M liability to \$6.3M grant equitable to BCHD cities taxpayers?
