

Overall Sentiment







Summary is below, but THIS PUBLIC COMMENT includes the material at the LINK above.

The public record of the GPAC and of public comments is progressive and extensive on the matter of

Public/Institution FAR. With the exception of member Lamb, no written comments appear on the topic of the FAR (subject to check) by other GPAC members. As is clear to any reader, there is a robust discussion/simulation/documentation of the impacts of height, mass, and FAR differences in Public (P-CF) usage submitted to the record. The damaging impact of excessive FAR development is demonstrated with visualizations.

In addition, the GPAC had a paid consulting firm to provide support, analysis and respond to questions. As typical public committees go, GPAC was relatively resource rich during its operation.

CONCLUSION

- 1) The assignment of 0.75 FAR for most P/I/O (Public zoning) is consistent with the surrounding neighborhoods.
- 2) Furthermore, removing the subjectiveness of the FAR determination from the CUP process for P-CF is consistent with the State mandate of objective standards in planning and design requirements and remove (to the extent possible) the subjective standards.
- 3) The Public/Institutional FAR is 0.75, except in limited cases where City of Redondo Beach municipal uses are 1.25 FAR.



Holly Mitchell, our County Supervisor, is a big fan of swimming and might help with funding.


North Redondo is sorely in need for our next community garden. We could look for funding.

As a representative of the cannabis industry generally, and of an operator with a potential property in Redondo Beach, I am writing in support of the location requirements and buffer zones as drafted. I commend the Council and Staff on the years of work that have gone into this process already. The maps and regulations have been drafted thoughtfully with several rounds of community input.

With respect to the commercialization of cannabis, the permitting of regulated cannabis retail shops is the single most important and impactful action a city can take to support community safety in post-legalization California. The most effective way to eradicate the illicit market and to ensure cannabis stays out of the hands of children is to provide safe, legal access to regulated retail outlets. The City's work to date to ensure that future cannabis stores are located properly within Redondo Beach has been prudent and comprehensive, and broadly reflects the community's needs and desires.

As for the licensing process, I support the property requirement as part of the application. This, along with the required Zoning Verification Letter, ensures that applicants have access to compliant property and will greatly reduce the amount of time and resources the City spends on the application process.

Finally, I would ask again for the City to consider a qualified lottery for the permit selection process. Having been through multiple competitive licensing processes in several different jurisdictions, our experience is that qualified lotteries work best. The City's desired criteria can still be used to qualify applicants, ensuring the community's needs and desires are being met by prospective retailers. However, instead of scoring applications and ranking them, the City should instead use a randomized selection process of qualified applicants only to designate the applicants that are then eligible to proceed with the permitting process.

This method removes ambiguity in the selection process and reduces the City's litigation risk. It also greatly reduces the time dedicated to administering and defending the scoring, and reduces the number of appeals the City will have to process.

I am writing to express my concerns regarding the proposed legislation allowing cannabis retail shops in Redondo Beach, and I would like to emphasize the importance of responsible implementation, particularly regarding the establishment of exclusion zones around schools and daycare centers. Please do not rush through this without conducting a thorough and comprehensive study with more input from residents. Let's spend at least as much time and effort on this as on the new city logo.

I fully support the inclusion of extended buffer zones around middle and high schools to ensure the safety and well-being of our youth. It is crucial that these exclusion zones are enforced without exception, and I strongly urge against any attempts to override or relax them for specific locations. The protection of our youth should be the top priority.

I also advocate for a cautious and thoughtful approach to the legislative process. Rushing through this without comprehensive input from the community might lead to oversights and unintended consequences. Therefore, I encourage you to take the time to gather additional input from various stakeholders including the PTAs and BCHD before finalizing the legislation.

Additionally, I propose updating the code to include a tax on the delivery of cannabis to Redondo Beach. This presents an opportune moment to enhance our city's revenue streams while embracing the growing cannabis industry.

If the legislation permits storefronts, it is imperative to establish clear guidelines on their appearance and enforce strict age restrictions. We must avoid normalizing the exposure of cannabis retailers to our youth. I recommend that any cannabis retailer adhere to a standard of upscale and non-descript storefronts that seamlessly integrate into our cityscape. We should aim to avoid the stereotypical imagery often associated with cannabis shops, such as prominent green crosses and clever puns on weed, which can have a negative impact on our community's perception.

Let us prioritize the thorough study of all aspects involved, seek extensive input from the community, and carefully weigh the potential consequences before making any decisions.

I urge the city council to consider a delivery only model for cannabis. This will not only allow for cannabis access to residents but will provide a level of safety for our youth. The peer-review day is overwhelmingly clear, demonstrating that youth who routinely see cannabis marketing (billboards, digital marketing...) and who see/walk past cannabis storefronts are more likely to use cannabis within 30 days. Peer-review data had overwhelmingly demonstrated that cannabis is detrimental for the developing youth brain and increases anxiety, depression, suicidal ideation and suicide attempts among many other negative associations.

I urge the city council to act in a transparent manner and engage the community in townhall meetings and to ensure that a public health voice is a partner in the decisions as they pertain to cannabis in our city and our youth.
