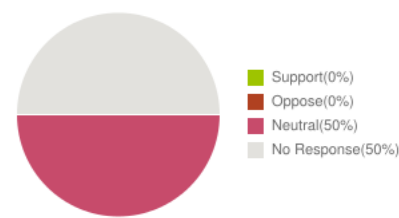

Overall Sentiment

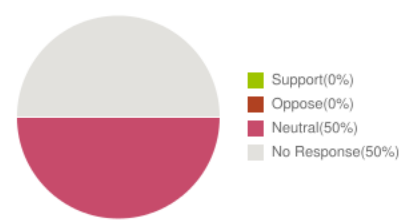

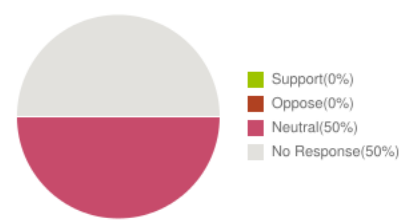

Hello, I'm Brandee Keith with the South Coast AQMD. I wanted to share the following updates from our agency:

Grant Funding for Charging Infrastructure
California Energy Commission (CEC) is now taking applications for grant funding for Charging Infrastructure for Government Fleets under their Clean Transportation Program. Up to \$30 million is available for projects that will provide electric vehicle charging infrastructure for light-duty government fleets. The purpose of these funds is to support electrification of government fleets, local government goals of sustainability and/or climate action plans and reduce vehicle emissions in disadvantaged and/or low-income communities.

I refer the Mayor and Council to communication regarding the GPAC and the FAR issue for Public/Institution. As I demonstrate, back to 2022, the work recommendation was to remove the "I know it when I see it" standard from FAR, and instead to follow State guidelines and create objective standards. Further, the FAR proposals of 0.75 and 1.25 were contained in several GPAC records that were published and in the NOI for the GPAC EIR. As such, the record is valid and complete.
