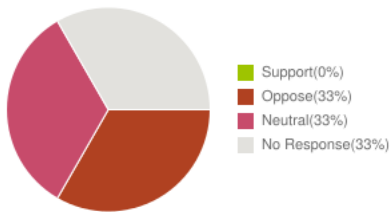

Overall Sentiment



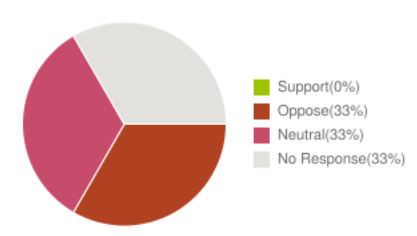

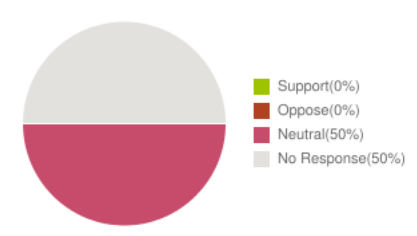

Good evening Mayor and Council Members,

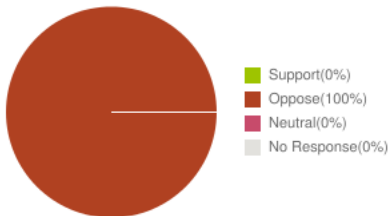
