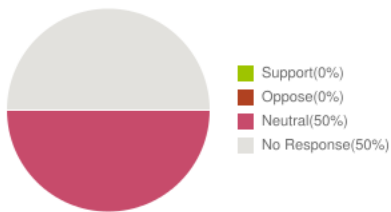

Overall Sentiment



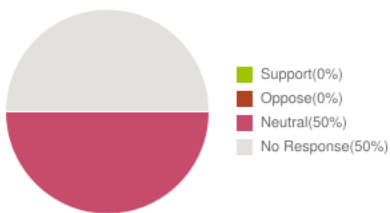

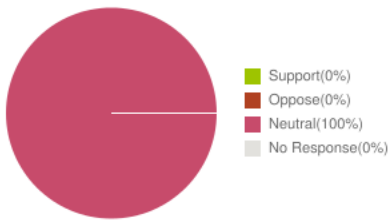

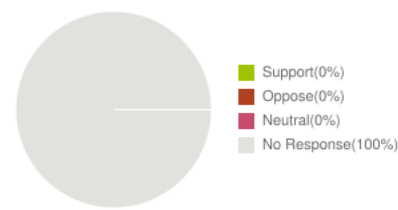

Outside of Dave's Ole Bookshop, however, there are 3 utility boxes. I ask that you direct staff to ask an artist to do 'books are fun in the sun/at the beach/ in the library' themed designs to "placemake" that area around the small business that is there- Redondo Beach's only bookstore. I realize yall are going 1 box per district - but ARTesia is supposed to A-R-T -esia per the AACAP. So it would be great if we could disproportionately advance art on ARTesia, then cover the rest of the City.
