**ADOPT RESOLUTION NO. CC-2207-057; A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, CALLING FOR THE HOLDING OF A SPECIAL MUNICIPAL ELECTION AND REQUESTING THE BOARD OF SUPERVISORS OF THE COUNTY OF LOS ANGELES TO CONSOLIDATE A SPECIAL ELECTION FOR DISTRICT 4 TO BE HELD ON TUESDAY, NOVEMBER 8, 2022 WITH THE STATEWIDE GENERAL ELECTION FOR THE SUBMISSION OF THE QUESTION OF THE RECALL OF CERTAIN OFFICER AND THE ELECTION OF CANDIDATE IF THE RECALL PREVAILS; AND**

**LOS ANGELES COUNTY REGISTRAR THREE (3) COST ESTIMATES\* FOR CONSOLIDATING CITY SPECIAL ELECTION WITH NOVEMBER 8, 2022 STATEWIDE GENERAL ELECTION:**

- 1) Recall Only \$36,899.00;**
- 2) Recall with Citywide Measure (without full text of initiative ordinance) \$214,760.96**
- 3) Recall with Citywide Measure (with 39-page full text of initiative ordinance) \$297,568.26**
- 4) The County has declined to assist in conducting our special election on any other dates other than in consolidation with the November 8<sup>th</sup> Statewide General Election.**

\*County confirms that there is a 5.5% COLA increase which could potentially increase the overall price by \$5K for the City/Complete and \$1K for the District (recall) Only. Changes in these estimates do not include unanticipated increases in labor and/or operational costs which may result in significant variances.
