



Overall Sentiment





The Redondo Beach City Council is playing fast and loose with the Brown Act and the public's right to participate in government decisions. There is the distinct smell of corruption in the air, recalling shades of the City of Bell.

In the last few months, a majority voting bloc of Redondo Beach Councilmembers Obagi, Nehrenheim and Loewenstein, arguably violated the Brown Act's public participation laws when they changed agenda items late at night and voted without notice to the public. In one case, they voted to expend more than \$270,000 of taxpayer funds for a special election that was unagendized, unnecessary, and only benefited their crony councilman Zein Obagi. The intent was to confuse the recall of the negligent Obagi with the Cannabis issue. Before the vote, both the City Clerk and the City Attorney warned of the violations. Residents should have had notice and an opportunity to comment before these decisions were made.

Recently, the League of Women Voters called out the blatant effort to confuse voters with an open letter rebuking the Council's actions. On September 13, the City Council received a letter from the Fraud and Corruption Bureau of the LA District Attorney, pointing to the two meetings in June and July, and claiming the Council violated the spirit of the Brown Act, arguably violating the law by ignoring the right of the people to participate in their government.

Yet, these men, Obagi, Nehrenheim and Loewenstein, who play fast and loose with our democratic process, voted tonight to give the Clty Council an 80% raise - to pay them more than any other comparably sized City. Ignoring the concept of public service, they whined about how hard it is for them. Those who are called to public service for the right reasons are not looking at the pay. These same men have expressed their intent to sell our Fire Department to L.A. County, and they have created a commission that is working to dismantle the historic protections, checks and balances that Redondo Beach residents have in place such as the elected offices of city attorney and city clerk.

Residents should beware. We've seen it before: this is how corruption begins in City government.






