## **RESOLUTION NO. CC-1910-070**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, AUTHORIZING A FISCAL YEAR 2019-2020 BUDGET MODIFICATION TO APPROPRIATE \$27,400 IN STATE OFFICE OF TRAFFIC SAFETY GRANT FUNDS TO THE INTERGOVERNMENTAL GRANTS FUND

WHEREAS, it is the intention of the City Council of the City of Redondo Beach to review the adopted budget from time to time; and

WHEREAS, the City of Redondo Beach ("City") was awarded a grant from the State Office of Traffic Safety ("OTS") for the Pedestrian and Bicycle Safety Program in the amount of \$27,400; and

WHEREAS, the grant funds will be made available to the City for the period of October 1, 2019 to September 30, 2020; and

WHEREAS, the City Council has approved the receipt and appropriation of past grant funding for similar police programs; and

WHEREAS, the City Police Department will use the monies to provide frontline police services involved in the enforcement of laws directly related to pedestrian and bicycle safety as approved by OTS; and

WHEREAS, the City's adopted budget must be modified in order to accept these funds for the 2019-2020 fiscal year.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. That the amounts allocated in the budget for Fiscal Year 2019-2020 and the amounts required to meet conditions which have arisen during the budget year, require a modification in the budget appropriations; and, upon recommendation of the City Manager, the budget appropriation as adopted for Fiscal Year 2019-2020 is modified as follows:

\$27,400 from the grant awarded by OTS shall be appropriated to the Intergovernmental Grants Fund.

SECTION 2. Pursuant to Section 11(f) of the City Charter, the City Clerk is hereby directed to correct the budget records of said City for Fiscal Year 2019-2020 in accordance with the above modification.

SECTION 3. The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.
