

**RESOLUTION NO. CC-1910-073**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, AWARDED A CONTRACT TO R.E. SCHULTZ CONSTRUCTION INC., A CALIFORNIA CORPORATION, IN THE AMOUNT OF \$234,800 FOR CONSTRUCTION OF THE PLAYGROUND RUBBERIZED SURFACE REPLACEMENT PROJECT, JOB NO. 30760**

WHEREAS, the playground rubberized surfacing at the Gregg Parkette, Franklin and Alta Vista Parks need to be replaced; and

WHEREAS, on June 18, 2019, the City Council of the City of Redondo Beach approved the funding and the scope of work for the Playground Rubberized Surface Replacement Project, Job No. 30760 (Project), as part of the Fiscal Year 2019-2020 Capital Improvements Program (CIP); and

WHEREAS, the City of Redondo Beach ("City") Engineer has reviewed the Project and recommended it as maintenance; and

WHEREAS, pursuant to Article XIX, Section 19.1, proposed work consisting of maintenance or repair does not require competitive bidding; and

WHEREAS, on August 8, 2019, the City Clerk advertised for competitive bids to obtain best pricing for the Project although it was not required to do so; and

WHEREAS, on September 5, 2019, bids for the Project were received and publicly opened in the City Clerk's Office; and

WHEREAS, R.E. Schultz Construction Inc., a California Corporation (R.E. Schultz Construction Inc.), is the lowest responsible bidder for the Playground Rubberized Surface Replacement Project, Job No. 30760, as more particularly described in the plans and specifications thereof, and incorporated herein by reference, and is awarded the contract for this Project in the amount of \$234,800; and

WHEREAS, R.E. Schultz Construction Inc. shall provide all applicable insurance certificates and bonds to the City for approval prior to the execution of the contract; and

WHEREAS, sufficient funds have been appropriated for this Project in the adopted FY 2019-2020 Capital Improvements Program Budget; and

WHEREAS, on October 1, 2019, the City Council approved the Plans and Specifications for the Project.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1: The City Council of the City of Redondo Beach, California approves the Plans and Specifications for the Playground Rubberized Surface Replacement Project, Job No. 30760.

SECTION 2: The City Council of the City of Redondo Beach, California, awards the contract for the Playground Rubberized Surface Replacement Project, Job No. 30760 to R. E. Schultz Construction Inc. in the amount of \$234,800 on the condition that all applicable insurance certificates and bonds shall be provided to the City for approval prior to the Mayor executing the contract on behalf of the City.

SECTION 3. The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.
