#### O. CITY MANAGER ITEMS

O.1. DISCUSSION AND POSSIBLE ACTION TO ADOPT A RESOLUTION TO RATIFY THE CITY MANAGER'S PROCLAMATION OF LOCAL EMERGENCY REGARDING THE SERIOUS AND IMMINENT THREAT OF NOVEL CORONAVIRUS (COVID-19) IN THE CITY OF REDONDO BEACH

ADOPT BY TITLE ONLY RESOLUTION NO. CC-2003-014, A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, RATIFYING THE ACTION OF THE CITY MANAGER ACTING AS THE DIRECTOR OF EMERGENCY SERVICES IN PROCLAIMING THE EXISTENCE OF A LOCAL EMERGENCY IN THE CITY OF REDONDO BEACH.

City Manager Hoefgen gave a report and discussed the following regarding the coronavirus threat:

- Trying to be quick and proactive to the threat
- Taking actions necessary to safeguard public and employees
- City Manager issued a proclamation of a local emergency related to COVID-19 coronavirus on March 12 last week.
- Redondo Beach among the first in South Bay to declare a local emergency, along with state, federal and county declaration of emergency
- Working closely with staff and Council throughout the process
- Resolutions before Council tonight to ratify declaration of a local emergency and all subsequent actions and steps that have been taken during the interim period
- Reviewed actions taken
  - o Increased cleaning of restrooms and City facilities
  - Closed three senior centers
  - All senior operations cancelled
  - Senior excursions cancelled
  - Special events in the City cancelled, full closure of PAC
  - Beach Live Festival postponed
  - Spring break camps cancelled
  - Social distancing, good hygiene
  - Limited employee work-related travel
  - Contingency plan for continuity of government
  - Redondo Beach libraries and activities closed
  - Closure of Redondo Beach School District
  - Closed RV Farmer's Market and Veteran's Park Farmer's Market closed
  - Closed Perry Park Teen Center
  - Recreational after school programs and operations have been cancelled
  - Redondo Beach City offices closed to public as of today
  - Alternative systems and procedures taking place
  - o Redondo Beach Police and Fire Departments continue to respond to calls for service
  - Fire inspection service suspended
  - Public Works and City contractors continue to perform maintenance and repair work
  - Suspended street sweeping enforcement
  - Meetings suspended
  - IT exploring accessibility of meetings
  - Alternative methods for public participation
  - March 17 through March 31 all gatherings of 50 or more prohibited

- Social distancing 6 feet apart and access to hand washing
- March 17 through March 31 all restaurants closed in Redondo Beach and throughout the county except for delivery or take-out dining or via drive-through
- March 17 through March 31 all bars, nightclubs, gyms, fitness centers, movie theatres, live performance theatres, bowling allies and arcades closed
- Next 90 days utility shut offs and late penalties prohibited
- Duration of emergency period temporary moratorium of evictions

Jacqueline Sun, Beach Cities Health District, spoke on the following:

- Activated the District Operation Center to better respond to the COVID-19 pandemic
- Operational objectives
- Information on their website for assistance along with having a hot line at 310 374-3426 x256

Dr. Bill Kim, Chief Medical Advisor, Beach Cities Health District, gave a health update and discussed the following:

- Monitoring situation closely
- Contact with LA County Department of Public Health
- 144 cases diagnosed as of today
- More cases being diagnosed
- Pandemic starting to take off in the community
- Recommended social distances for everyone and social isolation for those 65 and older and with illnesses
- Prevention of spreading
  - Stay home, wash hands, don't touch face, avoid close contact, disinfect frequently, cover mouth when cough or sneeze, get a flu vaccine, face masks, stay home if sick, not call 911 unnecessarily

In response to Mayor Brand regarding parks and playgrounds being closed, Community Services Director John La Rock explained that the park facilities and grounds are not closed at this time consistent with all other California park and recreation member cities.

Councilmember Loewenstein expressed concern with playground surfaces and also expressed concern with kids playing together in groups which is inconsistent with closing the schools.

Councilmember Horvath also concurred and recommended people following all recommendations from the City and the Department of Public Health.

Councilmember Horvath expressed concern with calling 911 unnecessarily and noted ER's can get overwhelmed easily and spread the virus.

Dr. Kim stated those over age 70 with a fever of 99.8 and a cough with pulmonary symptoms should call their doctor but not call 911. He suggested testing can be done outside of the hospital setting, but tests have been set up at the hospitals to test appropriately.

Fire Chief Metzger stated the Fire Department has amended their response protocols, committing only one fully equipped individual being the primary patient care individual unless he needs assistance. He said the remainder of the crew is available to assist if needed, limiting exposure to the public.

Dr. Sam Stratton, Chief Medical Advisor to Police and Fire, stated measures being taken are standard and appropriate throughout California. He said the virus is primitive with no DNA and is expected, in time, it will begin to mutate to not be as infectious such as in the spring. He said social distancing and limiting human contact with others is very appropriate. He also said a vaccine is projected to develop in a year to 18 months. He stated Redondo Beach Fire and first responders throughout the county have enacted a

treat and release policy which allows fire fighters to release a patient without transport, if needed, and advise the patient to call their physician which is different from normal EMS practices. He also advised washing hands at all times and use hand sanitizer as needed. He also expressed concern with kids playing on playgrounds at this point which may distract Fire and Police from more important calls if enforced. He suggested having public announcements for parents to wipe down equipment. He also said the virus seems to move quickly from hand to mouth contact.

Mayor Brand suggested using common sense and that the playgrounds be off limits at this point.

In response to Councilmember Horvath regarding protocols for the Fire Department, Dr. Stratton stated they are using N95 masks and having a triage tent with universal precaution equipment and also limiting exposure of the health care providers. He also said patients calling 911 are being asked screening questions and are following precautions for high risk calls, but calls not being considered high risk for infection are responding in a more standard format.

Chief Kaufman stated the Police Department has worked very closely with the Fire Department to ensure their protocols are similar to theirs to include prescreening 911 calls, adjusting response to do phone reports, using protective gear, masks as needed, having personnel ready, calls for service have been relatively the same, team of officers both in the north and south visiting bars, restaurants, and businesses that fit the order and educating them and talking to over 100 establishments with 100% compliance.

Mayor Brand called for public comment.

Liliana stated she has a dance and music school in the City, supported the Los Angeles Public Health, and asked to not close the Redondo Beach Performing Arts Center until the end of June. She said the theater is very large and 50 people or less would have appropriate social distancing and said there is a creative way to dance far away from each other in small groups.

Jonathan Shrednick, Completely Pickled, believed they have a safe environment at the farmers market, noted there are less people, no carts/doors with hand sanitizers, and asked that it be open to help people get food and supplies. He also said LA County has given them the okay and asked the City do the same.

Gary Mlynek, District 5, agreed with keeping the farmers market open, expressed concern with imposing Marshall Law, stated the virus dies quickly on cotton material, and expressed concern with restricting lives with making a living.

Dr. Stratton explained that this is more lethal than the flu which has a 2% mortality rate, and there is no vaccine for COVID-19 with a potential to break out and spread rapidly. He also said the normal flu is .9% mortality rate and also affects younger adults more vigorously than the flu.

Dr. Kim said that the virus can last nine days on a flat surface, the overall mortality is around 2% and older patients approaches 15% mortality rate after age 60 to 65. He said this is not a flu and everything possible needs to be done to mitigate it.

Luis Vasquez, Redondo Beach, suggested considering free Wi-Fi to all residents of Redondo Beach to help reduce the spread of the virus.

There being no one else wishing to speak, Mayor Brand closed the public comment period.

Councilmember Emdee stated this is a virus and the population does not have antibodies against it. She said the numbers are huge and the numbers of the countries that didn't act quickly enough were closer to 3 to 5%, with number of deaths by a factor of 10. She also said the number of cases is higher without acting quickly in addition to taxing of the health centers. She pointed out that Torrance Memorial and Little

Company of Mary only have 954 beds between them with only 350 beds available for the entire area. She said measures are taking place to avoid this becoming a catastrophe and will grow to the 10<sup>th</sup> power if the spread isn't stopped now.

Councilmember Horvath agreed and supported being overly cautious and asked about websites for medical sound information. Dr. Stratton suggested the CDC website which has information for health care providers and citizens, and the California Public Health Department which gives information more specifically to California.

City Manager Hoefgen also suggested the webpage for the Los Angeles County Department of Public Health.

Councilmember Nehrenheim expressed concern with seniors and those immobile that don't have easy access to food supplies, and the volume of people going through supermarkets. He suggested the farmers market in the Riviera Village and Veterans Park be kept open with an outdoor environment with plenty of space.

Community Services Director La Rock stated he spoke with the LA County Department of Health and stated the first guideline would be selling only edible produce, no prepared foods, no non-food vendors, allow only 50 people in the market location at a time, that city personnel record the basic contact information of every seller and person shopping at the market, no samples of foods provided at the market, and suggested observing the Torrance farmer's market this Saturday and learn their best practices.

Mayor Brand asked about the differences between a normal food market versus a farmer's market. Community Services Director La Rock explained that the determination was made on crowds of more than 250 and 50 people on City property.

Councilmember Nehrenheim asked about food delivery for seniors and those on fixed income that can't pay for food delivery services.

Jacqueline Sun, Beach Cities Health District, stated they have their hotline for contacts for assistance especially for older adults such as grocery shopping, and coordination regarding donations in trying to best support the older adults.

Councilmember Nehrenheim stated the county is working on a plan for those who will be quarantined, to include beds, renting hotel rooms, and the City is working hard with other agencies.

City Manager Hoefgen stated that farmer markets are currently cancelled from March 15 to April 30 but suggested a modification such as "until further notice" and also suggested bringing back this item at the March 31 City Council meeting. He also said the prohibition currently in place could be taken out of the resolution.

Councilmember Emdee stated the Salvation Army is expanding their Meals on Wheels program. She also suggested the motion include the City Manager to review options to open the farmer's market.

Mayor Brand asked about the playgrounds and nail salons. Assistant City Manager Witzansky stated that nail salons are not prohibited under the current order.

Councilmember Loewenstein referred to the exponential growth and reviewed an article which states 40,000 cases within 30 days and if waited, 10.24 Million cases. He also said Singapore and Taiwan have extensive experience fighting SARS and MERS bringing it under control very quickly with very few infections. He also expressed concern with shared facilities and exponential growth. He pointed out that younger people are dying from this virus and supported a short-term sacrifice to stop the spread.

Mayor Brand supported public playgrounds being closed.

Councilmember Emdee believed parents are keeping their kids home and did not support putting too much strain on staff for enforcement.

City Attorney Webb suggested as a compromise marking off parks as closed with yellow police tape.

City Manager Hoefgen suggested posting signs related to hygiene at each park site.

Councilmember Horvath suggested just recommending that residents not use play structures but can use the open space.

Councilmember Loewenstein suggested considering the tape as a good compromise.

Motion by Councilmember Emdee, seconded by Councilmember Horvath, to adopt by title only Resolution No. CC-2003-014, a Resolution of the City Council of the City of Redondo Beach, California, ratifying the action of the City Manager acting as the Director of Emergency Services in proclaiming the existence of a local emergency in the City of Redondo Beach, and adopt by title Resolution No. CC-2003-016, A Resolution of the City Council of the City of Redondo Beach, California, ratifying the action of the City Manager acting as the Director of Emergency Services in issuing public orders by the City Manager under the City of Redondo Beach emergency authority.

  - Decision Package #5 equipment and supplies for response of Coronavirus outbreak
  - Decision Package #6 and Budget Response Report #11– purchase of replacement AED's in City facilities
- Estimated ending fund balance of approximately \$1.5M staff recommendation to leave this balance unspent

Assistant City Manager Witzansky gave a report and discussed the following:

- Staff to bring back a complete revision of the projected revenues and expenditures significantly adjusted as a result of COVID-19 and the \$1.5M may completely vanish which may require dipping into reserves
