City Manager Hoefgen gave a report and discussed the following:

- Declared a local state of emergency on March 12
- Closures and actions taken
 - Three senior centers shut down
 - Cancelled special events
 - Restrictions on PAC and then completely shut down
 - o Teen Center and both libraries shut down
 - o City offices closed to the public
 - After school program suspended
 - City Advisory Committee meetings suspended
 - Modifications in conducting businesses
 - All actions confirmed by City Council two weeks ago
 - Many additional closures put in place this past week
 - City pier closed
 - Coastal parking spaces, parking lots, City parts closed in conjunction with closure of beaches
 - Widespread compliance with stay away orders
 - Actions required to protect public health
 - Resolution confirming prior actions
 - Reviewed more recent actions and closures
 - Shutdown March 28 through April 24 subject to extension if necessary

Mayor Brand reviewed actions taken in the City protecting public health; stated the Galleria will be a COVID-19 testing site; thanked staff, Police, Fire and those on the front lines; and stated social distancing is the key.

Councilmember Nehrenheim asked about any impacts to the residents on the Esplanade. City Manager Hoefgen noted a continued strong police presence and widespread compliance.

Chief Kauffman stated the departments have changed and shifts have been adjusted to avoid cross contamination. He said all of the special assignments are out in the field with plenty of personnel out in the street to police certain areas and there are officers assigned to patrol in every district. He reviewed the schedule of their deployment with larger physical presence to avoid enforcement action and every measure has been taken to cover exposures as well.

City Manager Hoefgen stated information is still being gathered regarding testing and John Alderson from QIC offered the Galleria for a potential site for testing which will include the BCHD, Police Department and Public Works. He believed it will be limited but will be in the City limits.

Chief Metzger reviewed the Fire Department's calls which start with dispatch with a series of questions regarding a viral infection which information is passed onto the crews. He said they still respond with five people at the scene and only one person is being sent in with body substance isolation gear. He said their

call volume has dropped with an average drop of around 20%. He also said they are spending a lot of time working with housing entities and facilities, getting out information with questions and facts.

In response to Councilmember Nehrenheim regarding the Kensington issue, Chief Metzger stated they have experienced a number of incidences with residents identified as COVID-19 positive and LA County Health is keeping the information. He said the Fire Department is still making responses into Kensington and are managing the situation as much as possible given the circumstances. He also explained that is an environment that seems concerning causing their employees to be on edge and said they are in close contact with all of their people with no signs or symptoms of illness. He said screenings take place and employees are being monitored.

In response to Councilmember Emdee regarding protecting the first responders and having a contingency plan, Chief Metzger explained they have been in close contact with the Fire Department's Medical Director and the Department of Health on appropriate response protocol. He also said they have been in contact with the Fire Association Leadership to discuss COVID-19 concerns and addressing them in a meaningful way.

Councilmember Emdee thanked the first responders for everything they're doing.

Mayor Brand Called for public comment.

Chief Deputy City Clerk Vickie Kroneberger read emails as follows:

Eugene Solomon asked about the City contingency plan regarding the Police Department and/or Fire Department having an outbreak and not having adequate staffing for community response.

Chief Metzger reviewed contingency plans in place that will address a reduction in staff numbers.

Chief Kauffman stated for every team that is working, there are five teams in reserve which do not crosscontaminate with another team being kept completely separated. He also reviewed their testing procedures and said there is a contingency to go beyond this if needed such as a regional policing model.

Tom Bauer commented on the emergency order and the eviction ban and expressed concern with not being paid rent. He asked that evictions not be banned, suggested slowing the process down, and no landlord evicting in this environment.

City Manager Hoefgen stated there were provisions made at the state level regarding a ban on both residential and commercial evictions and stated the duration on the ban of evictions runs through the duration of the emergency through April 19, and this will be revised for clarification.

There being no one else wishing to speak, Mayor Brand closed the public comment period.

Motion by Councilmember Nehrenheim, seconded by Councilmember Loewenstein, to adopt by title only Resolution No. CC-2003-019. Motion carried unanimously, with the following roll call vote:

City Clerk Eleanor Manzano read Resolution No. CC-2003-109 by title only.

O.2. APPOINTMENT OF INDIVIDUALS TO SERVE ON THE REDONDO BEACH DISASTER COUNCIL.

Mayor Brand referred to Section 3-2.03 of the Municipal Code regarding a Disaster Council and membership and stated this needs to be formed which will be needed as the emergency unfolds regarding impacts, restarting, and environment concerns.

City Manager Hoefgen reviewed the Disaster Council with six standing members of the Council to include the Mayor (Chair), City Manager (Vice-Chair), Assistant City Manager (Assistant Director of Emergency Services), Police Chief, Fire Chief and Public Works Director. He said when it is convened, it will be required to follow the Brown Act. He also referred to another section of the Code regarding the ability to appoint additional representatives. He said this report is a followup to a referral made at the March 17 City Council meeting. He also reviewed his recommended appointments.

Councilmember Nehrenheim also recommended Phil Navarro for harbor representation, Mike Gavola, and Joe Nafissi.

City Attorney Webb reviewed the process and stated it is the City Manager's appointment under the Ordinance and City Council would be voting on the City Manager's appointments tonight.

Mayor Brand called for public comment.

Chief Deputy City Clerk Vickie Kroneberger read emails as follows:

Wayne Craig expressed concern with political appointees with little or no experience. He reviewed his security background and requested using members with more experience and reviewed his recommendations.

There being no one else wishing to speak, Mayor Brand closed the public comment period.

City Manager Hoefgen stated he is not prepared to appoint any other members tonight and said he stands by his recommendations which are not political appointments.

Councilmember Nehrenheim questioned not having representation from the Riviera BID or the harbor groups. City Manager Hoefgen stated Mr. Sanford is included who was a business owner in the Riviera Village BID as well as the Chamber having a presence.

In response to Mayor Brand regarding the harbor not being represented, City Manager Hoefgen stated City staff will be involved who has a lot of knowledge about the harbor and leases.

Councilmember Loewenstein noted the City has a very large boating community which should be represented.

Mayor Brand called for public comment.

Chief Deputy City Clerk Vickie Kroneberger read emails as follows:

Mark Hansen expressed concern with the water/harbor area being under-represented and suggested Waterfront and Economic Development Director Stephen Proud and Jeff Perkins, president of the King Harbor Association be included.

Councilmember Nehrenheim expressed concern with the list presented and stated he would like to see a more rounded list and to include the leaseholders.

There being no one else wishing to speak, Mayor Brand closed the public comment period.

Motion by Councilmember Emdee, seconded by Councilmember Loewenstein, to appointment the individuals as presented by the City Manager to serve on the Redondo Beach Disaster Council. Motion carried, with the following roll call vote:
