SUBJECT: ADAMS MIDDLE SCHOOL LEFT TURN RESTRICTION AND LOADING ZONE MODIFICATIONS

In an ongoing effort to reduce congestion and enhance vehicle and pedestrian safety around schools, staff has reviewed conditions along Ripley Avenue between Felton Lane and Lilienthal Lane to determine potential traffic control enhancements. Following presentation to the Public Works Commission on January 27, 2020, the Commission's recommendation of modifications to forward to the City Council include a left turn restriction from Ripley Avenue into Adams Middle School and the creation of one separate loading zone on Ripley Avenue.

The proposed loading zones would be installed between Felton Lane and Harriman lane and would be established with time limit parking restrictions during the school morning arrival and afternoon dismissal periods. An exhibit showing the potential roadway modifications is included below:



Staff will present the recommendations in the coming weeks at a future City Council meeting. The City Council will review staff's presentation, receive public input and discuss what actions to pursue. Residents are encouraged to attend and provide input.
