2 What this Amendment Does

- 2.1 This Amendment amends the Program Terms and Conditions (the **Program Guide**) to your merchant processing agreement by:
 - (1) Deleting Section 5 in its entirety.
 - (2) Deleting the reference to "30 days" in section 6.13 and replacing such reference with "60 days".
 - (3) Deleting Section 11 in its entirety.
 - (4) Amending Section 12.1 by deleting the last two sentences of that section and adding the following at the end of that Section:

At our request you shall return to us or destroy all of our confidential information in your possession or control. If no such action is timely filed by us following notice of a Public Records request, you may disclose the records. Notwithstanding the foregoing, you may disclose a copy of this agreement and any amendments thereto (including pricing information contained herein) to the extent required by applicable law or pursuant to your contracting policies and procedures that apply generally to all of your vendors.

(5) Deleting Section 16.2 and replacing it with the following:

The initial term of this Agreement is five years from the date your account is approved by our Credit Department and activated (the Initial Term). After the Initial Term, subject to section 16.3, this Agreement shall automatically extend for additional periods of one year each (an Extended Term).

(6) Amending the first sentence of Section 16.3 to state:

A party may give written notice to the other party, not later than 30 days before the end of the Initial Term or the Extended Term, as applicable, to terminate this Agreement at the conclusion of the then-current Initial Term or Extended Term.

- (7) Amending Section 18.2 to: (i) delete the reference to "45 days" and replace such reference with "90 days"; and (ii) delete the reference to "90 days" and replace such reference with "120 days".
- (8) Deleting the last sentence of Section 18.4.
- (9) Deleting Section 27.1 in its entirety.
- (10) Deleting the reference to "pursuant to Section 27.1" from Section 27.2.
