

Thank you City Council, in response to COVID-19, South Bay Family Health Care began Telephonic Health Services for non-emergent patients. All other visits are continuing at the RB Clinic. We are experiencing a 46% loss in medical care, a 100% loss in dental care, a 30% loss in mental health services, and projecting a \$546,207 loss in revenue. SBFHC is asking that you consider funding the dental clinic, upon reopening, we anticipate an influx for care. We are grateful for your continuous support.

(310) 802-6177 On behalf of South Bay Family Health Care (SBFHC), I would like to thank Mayor Brand and the City Council for its dedication to public service and the Redondo Beach community.

As you can imagine, Coronavirus Disease 2019 (COVID-19) has definitely impacted our ability to provide comprehensive safety-net health care services. As you know, on March 19, 2020, Los Angeles County was issued "Safer at Home" orders, and in response, SBFHC implemented the following countermeasures to prevent, prepare for, and respond to COVID-19:

- During the week of March 23, 2020, due to the urgency of COVID-19, SBFHC mobilized and began offering Telephonic Health Services to support social distancing, by limiting clinic visits for non-emergent routine patient care including, but not limited to, asthma management, bronchitis, non-emergent diabetes, medication refills, pink eye, colds, and appropriate pediatric visits. All visits deemed necessary by Providers are continuing to be seen at the Redondo Beach Clinic. Additionally, behavioral health (unless the patient is acutely depressed, etc. or a new patient) are receiving telephonic therapeutic sessions provided by SBFHC therapists.
- Since moving to telephonic care, we are experiencing a 46% loss in medical care, a 100% loss in dental care, and a 30% loss in mental health services. As we move into the 3rd quarter, we are projecting a 42% or \$546,207 loss in FY 2020-21 revenue.
- Direct Clinic Services: To further enhance response to COVID-19, clinical staff have been trained on the proper way to put on, use, and take off personal protective equipment (PPE) safely. In addition to proper hand hygiene, disinfecting clinic surfaces, and social distancing in a clinical setting. Plexiglass barriers are in the process of being installed to limit contact with patients during arrival and triage. The barriers are permanent fixtures and will remain installed at all SBFHC sites after the COVID-19 pandemic.
- On April 9, 2021, SBFHC began offering <u>all</u> employees personnel Rapid COVID-19 test kits. Staff members who are either symptomatic (i.e., experiencing fever, coughing, and in particular shortness of breath) or desire to be tested will be administered a test kit. A limited number of test kits are available for urgent patient testing.

2020-21 Funding Request:

Although the unprecedented occurrence of COVID-19 will impact SBFHC's clinic operations well into the future, we are asking the City of Redondo Beach to still consider our 2020-21 CDBG funding for the Redondo Beach dental clinic. The dental clinic has been closed since mid-March 2020, we are preparing to reopen as soon as we receive the proper clearances. We are also weighing the option of opening for emergency dental services only; however, the actual need versus sustainability is being assessed. Once the dental clinic is reopened, we anticipate an influx of patients requiring dental care.

Our frontline programs provide integral support in the county-wide crisis of homelessness and food insecurity. Our clients' needs are now greater than ever given the negative health and economic impacts of the COVID-19 pandemic. We urge you to approve funding through the HUD Community Development Block Grant program to support our ability to offer basic needs to the most vulnerable in our community.

Our services include providing weekly meals to all who are hungry, a twice-monthly food pantry in conjunction with the Los Angeles Regional Food Bank, infant supplies and clothing, as well as acting as a liaison to additional social services for our clients.
