Hello Ms. Manzano,

My family lives or Broadway between Garnet and Torrance Blvd. I have been living there since 1988. We, (or someone in my family) go through this intersection many times a day, either walking, riding bikes or driving a car. I personally have witnessed the aftermath of car accidents with pedestrians, car accidents with people riding bikes and car accidents with other cars.

I am grateful that the city is thinking they will take some action to minimize the accidents at this very dangerous intersection. The solution the city implements will be to add additional traffic controls and should address all 3 of the accident types previously identified. Three viable solutions would be;

- 1. Traffic signal (red, amber, green)
- 2. 4 Stop signs, on each corner
- 3. Stop lights (flashing Red light), one facing each road entering the intersection.

I personally believe making the intersection a four way stop would be the easiest to implement. The 4 way stop is very common in the beach cities and people will become familiar relatively quickly. On the down side of a solution with 4 stop signs, people in a hurry are more likely to do a "California stop" or possibly run the STOP sign hitting a pedestrian. Flashing red lights gives the same function as 4 stop signs with the additional characteristic of greater visibility. For this reason I believe a set of flashing RED lights would be the best solution to minimize accidents at the intersection.

Good day, I will preface this note by saying I own a condo, and live in at the corner of Catalina and Garnet, just one block from this intersection, and our garage entrance is on the east side of Catalina Ave. So, I am very familiar with this intersection and have crossed it many times in my 4 years living at this location. While I do believe something such as a 4-way stop with flashing led's around the stop signs, or blinking red stoplights would be of benefit at this intersection, I think that a 'no right turn on

While I do believe something such as a 4-way stop with flashing led's around the stop signs, or blinking red stoplights would be of benefit at this intersection, I think that a 'no right turn on red' would have no logically backed reasoning based upon this specific intersection. There is plenty of space to see vehicles coming and I see it as one of the safer intersections to allow right on red. Left turns are far more dangerous onto a 2-lane roads. So that begs the question, would you still let people go straight through or make left turns...both significantly more dangerous than right turns? What it would do is in fact make all residents who enter their

garages on Catalina, have to go around in bigger circles and stop at more lights and stop signs to get home.

I think a stoplight might impede traffic as it could easily get backed up crossing PCH or backing up drivers trying to turn right onto Torrance from PCH. With a stop sign, at least the traffic can continue moving on a consistent basis.

I would draw a comparison to the no right turn on Monterey from Herondo during weekday mornings. This sign serves no purpose in terms of safety, and in fact, causes most people to drive around the block, and make a left onto Monterey, which is significantly more dangerous based upon California's and the Local city rules regarding how close you can park to an intersection. Many states require a minimum distance of parking at 15-20 feet from an intersection, but, due to the number of cars and citizens in our cities and state, California nor LA have such rules.

I live on the 500 block of South Broadway. I use this intersection frequently, both in my car and as a pedestrian. Here are my recomendations in order of priority:

- 1. A roundabout featuring a centerpiece welcoming visitors to the beach.
- 2. Leave the intersection as it is. With the current flashing lights I feel safe crossing North-South as a pedestrian. In a car I never try to cross the intersection going North-South. I only make right turns from Broadway to Torrance and left turns from Torrance to Broadway. I have never experienced a traffic congestion issue.
- 3. Bulb outs, no opinion.
- 4. Northbound- Southbound right turn only. Don't care. I never cross this intersection going North-South in a car. I use Catalina or PCH instead. A good option for non-local drivers that don't know the intersection.
- 5. All-way stop, 4 lanes vs. 2 lanes, not a good idea.

Hello Eleanor,

First, thank you for allowing our input on this matter! I have lived ONE house away from this intersection for the past 3.5 years and I know that there are constant "close calls" as well as actually accidents that happen here...I literally hear them.

I was informed that there are 4 options. However, I would like to present a 5th option: Replace the yellow flashers with Red (more distinct) Lights that will have those traveling on Torrance Blvd be more aware of the STOP. Additionally, I think there should be better signage posted. EX: On Broadway-Use Caution, Oncoming Traffic Does Not have Stop Sign. On Torrance-Pedestrian Crossing! Use Caution!

IF this is not a feasible option, then I would have to digress to a traditional 4 way stop...as it is on most of the other cross streets. We DO NOT want a Roundabout or limited turning directions. I suppose a Stop light 'could' work if it was directly linked to when a Pedestrian pushes a button. (Like 2nd Street/PCH in Hermosa)
