

RESOLUTION NO. CC-2008-059

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, AWARDING A CONTRACT TO MIKE PRlich & SONS, INC., A CALIFORNIA CORPORATION, IN THE AMOUNT OF \$673,870.00 FOR CONSTRUCTION OF SANITARY SEWER REHAB – 2020 UPGRADES TO PCH/VISTA DEL MAR, JOB NO. 50150

WHEREAS, sanitary sewer segments within the City of Redondo Beach (“City”) periodically need to be improved; and

WHEREAS on June 16, 2020, the City Council of the City of Redondo Beach approved the Plans and Specifications for the Sanitary Sewer Rehab – 2020 Upgrades to PCH / Vista Del Mar, Job No. 50150 (“Project”), and authorized the City Clerk to advertise for competitive bids; and

WHEREAS, on July 29, 2020, bids for this Project were received and publicly opened in the City Clerk’s Office; and

WHEREAS, Mike Prlich & Sons, Inc., a California Corporation (“Mike Prlich & Sons”), is the lowest responsible bidder for this Project, as more particularly described in the plans and specifications thereof, and incorporated herein by reference, and is awarded the contract for this Project in the amount of \$673,870; and

WHEREAS, Mike Prlich & Sons shall provide all applicable insurance certificates and bonds to the City for approval prior to the execution of the contract; and

WHEREAS, sufficient funds have already been appropriated for this Project in the adopted Fiscal Year 2020-2021 Capital Improvement Program Budget.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The City Council of the City of Redondo Beach, California, awards the contract for the Sanitary Sewer Rehab – 2020 Upgrades to PCH / Vista Del Mar, Job No. 50150 to Mike Prlich & Sons, Inc. in the amount of \$673,870 on the condition that all applicable insurance certificates and bonds shall be provided to the City for approval prior to the Mayor executing the contract on behalf of the City.

SECTION 2. The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.
