Hi Debbie,

The City is interested in removing 15 of the 25 transient vessel moorings that were installed in Redondo Harbor as part of BIG Contract #11-109-701.

As we discussed this morning, usage of the moorings is extremely low (roughly 5%) and they are very expensive to maintain. We believe leaving just 10 moorings in place would adequately meet the demand for transient boaters, while allowing the City to significantly reduce maintenance costs. The grant was awarded in 2011 and the mooring field was installed in 2014.

Please let me know what is involved in obtaining approval for DBW to remove 15 of the moorings.
