## **RESOLUTION NO. CC-2101-001**

### **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH CALIFORNIA CONFIRMING THE ACTION OF THE CITY MANAGER ACTING AS THE DIRECTOR OF EMERGENCY SERVICES IN ISSUING AN UPDATED SUMMARY OF EMERGENCY ORDERS UNDER THE CITY OF REDONDO BEACH'S EMERGENCY AUTHORITY**

WHEREAS, California Government Code section 8634 empowers the City Council and delegated officials to promulgate orders and regulations necessary to provide for protection of life or property during a local emergency; and

WHEREAS, the City Council has specifically delegated this authority to the City Manager as Director of Emergency Services in Chapter 2 of Title 3 of the Redondo Beach Municipal Code; and

WHEREAS, on March 12, 2020, the City Manager acting as the Director of Emergency Services issued a proclamation declaring a local emergency due to the imminent threat of COVID-19 in Redondo Beach and has since issued a number of additional emergency orders to help protect residents, visitors and City employees and to combat the spread of the virus in the community, and

WHEREAS, the Mayor and City Council ratified the declaration of local emergency and have confirmed all emergency orders issued and implemented by the City Manager acting as the Director of Emergency Services pertaining to COVID-19; and,

WHEREAS, on March 19, 2020, the Los Angeles County Public Health Officer issued the Safer at Home Order, which has since been amended and superseded by a number of subsequent County emergency orders; and,

WHEREAS, on March 19, 2020 the Governor of the State of California issued Executive Order N-33-20 ordering all individuals living in the State of California to stay home or at their place of residence; and,

WHEREAS, on December 3, 2020, the Governor of the State of California issued a Regional Stay at Home Order, and later supplemented the Order on December 6, 2020, that provides for the current restrictions placed on residents of the Southern California Region; and,

WHEREAS, the most recent COVID-19 indicators within the County of Los Angeles, show an alarming and substantial increase in the level of daily reported COVID-

19 cases and an overwhelming number of hospitalizations that clearly demonstrate the need for continued emergency action; and,

WHEREAS, as of January 8, 2021, the Centers for Disease Control and Prevention (CDC) website listed the number of COVID-19 cases in the United States of America at 21,259,997 persons, including 359,849 deaths in the Country, and the Los Angeles County Public Health Department cited 871,404 cases (1,743 in Redondo Beach) and 19,719 deaths in Los Angeles County; and,

WHEREAS, following discussions with the Mayor and City Council on December 15, 2020 and January 5, 2021 regarding the need to assist residents who are at home more due to the regional state of emergency, the City Manager on January 6, 2021, acting as the Director of Emergency Services, ordered a temporary reduction in the fine amount for tickets issued for violation of citywide parking hour restrictions like street sweeping and has described the order in the Summary of City Emergency Orders Pertaining to COVID-19; and,

WHEREAS, the City Council desires to confirm the updated Summary of City Emergency Orders Pertaining to COVID-19 issued by the City Manager acting as the Director of Emergency Services under the City of Redondo Beach's emergency authority.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The updated Summary of City Emergency Orders Pertaining to COVID-19, attached herein as Exhibit "A" and incorporated into this Resolution, is confirmed.

SECTION 2. The City Manager is authorized to furnish information, to enter into agreements, and to take all actions necessary to implement preventative measures to protect and preserve the public health of the City from the COVID-19 Pandemic.

SECTION 3. The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.
