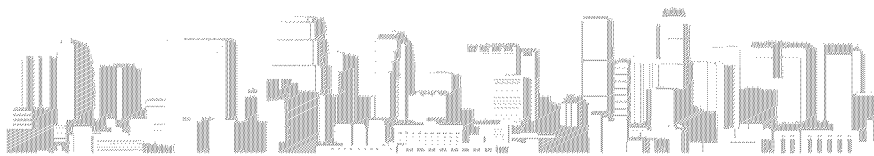

Agreement and Authorization for Use of Vote by Mail Ballot Drop Box City of Redondo Beach February 1, 2021 – March 2, 2021

Agreement and authorization has been approved by the *Los Angeles County Registrar-Recorder/County Clerk (RR/CC)* to allow the City of Redondo Beach to utilize the **Vote by Mail (VBM) drop box** listed below between **February 1, 2021 – March 2, 2021**.

The RR/CC will provide the city with the keys to requested official VBM drop box. The city will be responsible for managing the keys, maintaining the integrity of the drop box and will not duplicate the keys during the duration of the program. The VBM drop box keys will be returned to the RR/CC in their original condition.
