FIRST AMENDMENT TO LEASE AGREEMENT

Notwithstanding anything in the Lease to the contrary, all Applicable Percentages relating to Gross Sales of Restaurant & Bar operations at 100"H" Fisherman's Wharf shall not be the subject of any renegotiations and shall remain unchanged at three and one-half percent (3.5%) at the first "Renegotiation Date" established in Paragraph B.3 of Exhibit "E" to the Lease.
- 3. <u>Miscellaneous</u>. The Lease and this First Amendment constitute the entire agreement between the parties and supersede any previous oral or written agreements. All capitalized terms in this First Amendment shall have the same meaning as defined in the Lease unless otherwise defined herein. In the event of any inconsistency between this First Amendment and the Lease, this First Amendment shall prevail. This First Amendment may be modified or amended only by a subsequent writing executed by all of the parties hereto.
