- Approve a funding agreement with the County of Los Angeles to receive funds for the emergency housing Pallet project in an amount not to exceed \$420,000 as amended with addendum and modifying the Schedule
- Specify which location or locations will host the Pallet Shelters and for how long
- Direct the City Manager to create an Administrative Policy that specifies that only Redondo Beach residents who are experiencing homelessness will be admitted to the shelters
- If so desired, direct the City Attorney to return with an ordinance that prohibits camping within 500 yards of an emergency transitional housing facility that provides shelter to people experiencing homelessness
- o If so desired, direct the City Attorney to return with an amended ordinance that provides that in circumstances in which the provisions of the City's unlawful camping ordinance cannot be enforced pursuant to Martin v. Boise, camp facilities my be erected only between the hours of 5 p.m. and 10 a.m. similar to the City of San Clemente ordinance

Mayor Brand noted there will be security and the homeless in Redondo will have help along with other services.

In response to Mayor Brand, Fire Chief Metzger reviewed the helicopter access and believed the location would work for emergency needs and evacuating a patient.

Mayor Brand called for public comment via Zoom and eComment.

Ronson Chu said there are nearby cities addressing this issue and supported complying with Boise. He said the site selection may be difficult and supported using the Kingsdale location. He also pointed out that there are 420 veterans in the South Bay.

Janelle Scales supported approval and helping the most vulnerable members of the community.

Zein Obagi Jr. noted residents concerned about the schools nearby and suggested no camping within a certain radius of schools.

Sarah Klenha supported the project and approval to help the unhoused. She also suggested reaching out to the unhoused regarding the shelter project running successfully.

Kimberlee Isaacs supported the project and it moving forward, being part of a community that is being taken care of and safe throughout the City.

There being no comments, Mayor Brand closed the public comment period.

Councilmember Gran noted District 4 is angry but calmed down, thanked City Attorney Webb, supported the project which is a pilot program, noted people are willing to see how this works, thanked Public Works Director Semaan for checking out the Sea Lab site, did not support the project running for only six months and then being shut down but did support the project, said he spoke to his neighbors and read a letter from Ralph's who suggested staging the shelter near the Seaside Lagoon for the first four months of the project, supported being practical, stated one person will need to be living in the shelter by the end of the year, people have to be found that want to live in the shelter and the fence cannot be installed until mid-January, questioned how to execute the program such as when the Lagoon could be started and everything could be moved over by April, believed the Kingsdale site could be available now and suggested this consideration, and suggested using the Lagoon for a short period of time and then moving it over.

Public Works Director Semaan reviewed the schedule for Kingsdale and the Seaside Lagoon and believed they could be ready and made to work together.

Councilmember Emdee asked about the CDP. City Attorney Webb explained a waiver from the CDP could take place but suggested unintended consequences. He also supported making a final decision at this point and avoiding additional complexity. He also said if a waiver is received, both Kingsdale and the Seaside Lagoon could be started at the same time.

Public Works Director Semaan noted some minor detailed research needs to take place first. He also said the area looked at would be back where the restrooms are located.

Councilmember Emdee stated the timeframe is shortened and supported having a program coordinator to help with the paperwork. She also said the money being received is only during COVID and a vaccine would change the landscape and the program not lasting any longer than six months anyway. She suggested a second housing navigator or at least a program coordinator with the focus being on North Redondo homeless individuals. She also pointed out that she called the cities that were successful in this program and are not seeing any camping impacts.

Councilmember Nehrenheim supported the best site possible, pointed out that money isn't used out of the General Fund, supported moving this forward, and asked about Alta Vista Park. Chief Metzger explained any site selected is contingent upon emergency respondent accessibility and clearing so obstructions can be removed. He also said no helicopter could land until the area is cleared.

Councilmember Nehrenheim noted hotels that have opened up have integrated into the community with no impacts. He also shared a photo showing the break wall with swells and winds in the harbor and bad conditions which would never be an appropriate location.

Councilmember Emdee suggested having the Seaside Lagoon in the event Kingsdale doesn't work out.

In response to Councilmember Nehrenheim, Public Works Director Semaan stated the asphalt and the grading work is a necessity in order to make the site ADA compliant for access. He also said that Community Services Director John La Rock has been in the meetings with Harbor Interfaith and the county.

In response to Councilmember Horvath, Councilmember Emdee and City Attorney Webb explained the need for a housing navigator/program coordinator and the funding.

Motion by Councilmember Nehrenheim, seconded by Councilmember Emdee, to adopt by 4/5 vote and by title only Resolution Nos. CC-2011-087 and CC-2011-087, approving the two budget modifications and amending the first budget modification to include a housing navigator and/or program coordinator from the COVID funds set aside and CDBG funds. Motion carried unanimously, with the following roll call vote:

City Clerk Manzano read Resolution Nos. CC-2011-087 and CC-2011-088 by title only.

Councilmember Nehrenheim asked about the housing residents accepting the rules and violations taking place. City Attorney Webb stated the City Manager and City Attorney will return to Council regarding the terms of Harbor Interfaith and administrative policies.

In response to Councilmember Loewenstein, City Attorney Webb stated the 500 yards were based on the City of Los Angeles ordinance.

Councilmember Loewenstein pointed out that there would be no camping under the railroad tracks on Grant and the locations would have to be cleared and questioned enforcement at El Niño Park. He also asked how people will enter into the facility. He reviewed his concerns about Seaside Lagoon and the Kingsdale site as a location, but Kingsdale would be the best location as a choice. He also supported the 500-yard limit from the project.

Councilmember Emdee suggested flexibility and feasibility regarding the Seaside Lagoon.

In response to Councilmember Emdee, Public Works Director Semaan stated there will be no impact to the Transit Center. He also said the area is a staging area to include contractor usage and a storage area for Public Works

Community Services Director John La Rock gave a report on the CARES Act funding, the Seaside Lagoon as an option, and Harbor Interfaith.

Councilmember Loewenstein expressed concern with having 15 pallets at the Seaside Lagoon.

Motion by Councilmember Horvath, seconded by Councilmember Nehrenheim, to accept staff recommendation as follows:

- Make a finding that this program is exempt from CEQA environmental review for the reasons set forth in the Administrative Report and adopt the Notice of Exemption including as the first attachment
- Direct Staff to carry out the Pallet Shelter Temporary Emergency Transitional Housing Program
- Approve a funding agreement with the County of Los Angeles as amended with the addendum and
 modifying the schedule to install permitted fencing no later than December 30, to receive funds for the
 emergency housing Pallet project in an amount not to exceed \$420,000 as amended with addendum
 and modifying the Schedule
- Specify the location as being at the Kingsdale site for six months if feasible and if infeasible by December 30, 2020, to locate at the Seaside Lagoon to host the Pallet Shelters
- Direct the City Manager to create an Administrative Policy that specifies that only Redondo Beach residents who are experiencing homelessness will be admitted to the shelters
- Direct the City Attorney to return with an ordinance that prohibits camping within 500 yards of an emergency transitional housing facility that provides shelter to people experiencing homelessness
- Direct the City Attorney to return with an amended ordinance that provides that in circumstances in which the provisions of the City's unlawful camping ordinance cannot be enforced pursuant to Martin v. Boise, camp facilities may be erected only between the hours of 5 p.m. and 10 a.m. similar to the City of San Clemente ordinance
- Direct staff to return with a mechanism for adding an additional housing navigator or program coordinator to work in North Redondo for six months

Mayor Brand referred to the benefits of inclusionary zoning and supported slow displacement of residents in a community, maintain economic diversity in a community, and disperse affordable housing throughout the community. He also said he would like to see what other communities have done and how it has worked.

Councilmember Nehrenheim supported this item and suggested using the Mello Act at minimum.

Councilmember Horvath believed the bare minimum should be 20% similar to the Galleria and that this item continue moving forward.

Mayor Brand called for public comment via Zoom and eComment.

Holly Osborne asked about the nexus study, inclusionary housing, thresholds, and suggested using examples.

Community Development Director Forbes explained that inclusionary housing is requiring a housing development of a certain size providing a certain percentage of their housing as affordable.

Ms. Tam explained that the nexus is developing market rate housing causing the need for affordable housing.

Ronson Chu discussed options regarding mitigating traffic, such as reserving units for people who have worked or have been part of the community for a number of years.

There being no comments, Mayor Brand closed the public comment period.

Councilmember Emdee also suggested addressing the housing going towards people in the area already and meeting the need of people who are already here.

Motion by Councilmember Nehrenheim, seconded by Councilmember Loewenstein, to direct staff to come back with parameters for further discussion to include the Mello Act by the end of January. Motion carried unanimously, with the following roll call vote:
