

RESOLUTION NO. CC-2105-042

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, AWARDING A CONTRACT TO AMTEK CONSTRUCTION, A CALIFORNIA CORPORATION, IN THE AMOUNT OF \$133,333 FOR THE ELECTRIC VEHICLE CHARGING INFRASTRUCTURE PROJECT, JOB NO. 20770

WHEREAS, the State of California has set a goal for the continuous increase of zero emission vehicles and therefore charging infrastructure is needed to facilitate this goal; and

WHEREAS, the City of Redondo Beach ("City") desires to install electric vehicle charging stations at six City locations; and

WHEREAS, on January 19, 2021, the City Council of the City of Redondo Beach approved the Plans and Specifications for the Electric Vehicle Charging Infrastructure Project, Job No. 20770 (the "Project"), and authorized the City Clerk to advertise for competitive bids; and

WHEREAS, on February 25, 2021, bids for this Project were received and publicly opened in the City Clerk's Office; and

WHEREAS, Amtek Construction, a California corporation ("Amtek Construction") was the lowest responsible bidder for the Project, as more particularly described in the plans and specifications thereof, and incorporated herein by reference;

WHEREAS, on April 20, 2021, the City Council of the City of Redondo Beach awarded the contract for this Project in the amount of \$133,000 to Amtek Construction, but the amount should have been \$133,333; and

WHEREAS, Amtek Construction is still the lowest responsible bidder for the Project and shall provide all applicable insurances and bonds to the City for approval prior to the execution of the contract; and

WHEREAS, sufficient Capital Project Funds have been appropriated for this Project in the Fiscal Year 2020-2021 Capital Improvements Project Budget.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The City Council of the City of Redondo Beach, California, awards the contract for the Electric Vehicle Charging Infrastructure Project, Job No. 20770, to Amtek Construction, in the amount of \$133,333 on the condition that all applicable insurances and bonds shall be provided to the City for approval prior to the Mayor executing the contract on behalf of the City.

SECTION 2. The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.
