## **RESOLUTION NO. CC-2106-047**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, AWARDING A PUBLIC WORKS CONTRACT TO PAVEMENT COATINGS CO., A CALIFORNIA CORPORATION, IN THE AMOUNT OF \$720,725.75 FOR THE CONSTRUCTION OF THE CITYWIDE SLURRY SEAL PROJECT, PHASE 2, JOB NO. 41140

WHEREAS, the streets in the City of Redondo Beach, California have been evaluated and are in need of maintenance and repairs; and

WHEREAS, on April 6, 2021, the City Council of the City of Redondo Beach ("City Council") approved the Plans and Specifications for the Citywide Slurry Seal Project, Phase 2, Job No. 41140 (Project), and authorized the City Clerk to advertise for competitive bids on April 15, 2021; and

WHEREAS, on May 6, 2021, bids for this Project were received and publicly opened outside of the City Clerk's office; and

WHEREAS, Pavement Coatings Co., a California Corporation ("Pavement Coatings Co.") is the lowest and most responsible bidder for the Project, as more particularly described in the Plans and Specifications thereof, and incorporated herein by reference, and is awarded the contract for this Project in the amount of \$720,725.75; and

WHEREAS, Pavement Coatings Co. shall provide all applicable insurances and bonds to the City for approval prior to the execution of the contract; and

WHEREAS, sufficient funds have been appropriated for this Project in the adopted FY 2020-21 Capital Improvements Program Budget.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The City Council of the City of Redondo Beach, California, awards the contract for the Citywide Slurry Seal Project, Phase 2, Job No. 41140 to Pavement Coatings Co., in the amount of \$720,725.75 on the condition that all applicable insurance certificates and bonds shall be provided to the City for approval prior to the Mayor executing the contract on behalf of the City.

SECTION 2. The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.
