## **RESOLUTION NO. CC-2109-085**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, PROCLAIMING SATURDAY, OCTOBER 2, 2021 AS "10K SWIM FOR MENTAL HEALTH DAY" IN THE CITY OF REDONDO BEACH IN SPONSORSHIP AND SUPPORT OF THE SMS PHYSICAL THERAPY, P.C. FUNDRAISING WATER SPORTS EVENT FOR THE SOUTH BAY YOUTH PROJECT TO BE HELD IN THE CITY OF REDONDO BEACH COASTAL WATERS AND IN APPRECIATION OF THE COUNTY OF LOS ANGELES' EFFORTS TO PERMIT THE EVENT AND PROVIDE LOGISTICAL SUPPORT

WHEREAS, the City of Redondo Beach ("City") and the County of Los Angeles ("County") have determined that water access and coastal recreation are critical community elements in providing a healthy environment for residents and visitors to the City; and

WHEREAS, the City and the County provide and promote numerous parks and recreation facilities, programs and events for public use, enjoyment and general public welfare benefit; and

WHEREAS, the City supports the increased use of its coastal waters for recreation and sporting activities and is appreciative of its collaboration with the County and the services the County provides to maintain, activate and supervise the beaches; and

WHEREAS, in 2020, SMS Physical Therapy, P.C., founded by Dr. Sasha Speer, raised over \$1,200 in funds as part of an unofficial swim event and donated the funds to the South Bay Youth Project ("SBYP"), which is part of the South Bay Children's Health Center; and

WHEREAS, the SBYP offers a full range of child and youth focused mental health services in a clinical environment and local schools; and

WHEREAS, in 2021, SMS Physical Therapy, P.C. desires to raise over \$5,000 for the SBYP by holding a swim charity event; and

WHEREAS, the City has partnered with the County, local water sports professionals, and businesses to create open water swim events for the purpose of activating City's coastal waters; and

WHEREAS, the City desires to create annual open water swim events that integrate with internationally sanctioned swimming events to promote water sports and demonstrate the capacity and attractiveness of the County and the coastal waters; and

WHEREAS, the 10K Swim for Mental Health Day open water charity event will be held on October 2, 2021 and is expected to draw County residents of all ages who will participate in mental health awareness and fundraising a charity swim event; and

WHEREAS, local residents and spectators from the region will also be drawn to the event to enjoy the race and the County beach, and support SMS Physical Therapy, P.C fundraising for the benefit of SBYP.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. That the City of Redondo Beach does hereby declare Saturday, October 2, 2021 as "10K Swim for Mental Health Day" in Redondo Beach in support of the first charity swim to raise money for local mental health awareness and programs.

SECTION 2. That the City of Redondo Beach does hereby recognize partnerships with the County of Los Angeles, Dr. Sasha Speer and SMS Physical Therapy, P.C. for the organization and implementation of the open water charity swim event.

SECTION 3. That the City of Redondo Beach does hereby thank the County of Los Angeles for its review and permitting of the event and is grateful for the logistical services it will provide to support the event.

SECTION 4. The City Clerk of the City of Redondo Beach shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.
