A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, AUTHORIZING A FISCAL YEAR 2021-2022 BUDGET MODIFICATION TO APPROPRIATE \$100,000 IN STATE OFFICE OF TRAFFIC SAFETY GRANT FUNDS

WHEREAS, it is the intention of the City Council of the City of Redondo Beach to review the adopted budget from time to time; and

WHEREAS, the City of Redondo Beach ("City") was awarded a grant from the State Office of Traffic Safety ("OTS") for the Selective Traffic Enforcement Program (STEP) in the amount of \$100,000; and

WHEREAS, the City Council has approved the receipt and appropriation of past grant funding for similar police programs; and

WHEREAS, the grant funds will be made available to the City for the period of October 1, 2021 to September 30, 2022; and

WHEREAS, the City Police Department shall use the monies to provide frontline police services directly involved in the enforcement of traffic laws as approved by the funding authority; and

WHEREAS, the City's adopted budget shall be modified to accept these funds forthe 2021-2022 fiscal year.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDONDO BEACH, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. That the amounts allocated in the budget for Fiscal Year 2020-2021 and the amounts required to meet conditions which have arisen during the budget year, require a modification in the budget appropriations; and, upon recommendation of the City Manager, the budget appropriation as adopted in Fiscal Year 2020-2021 is modified as follows:

\$100,000 from the grant awarded by OTS shall be appropriated to the Intergovernmental Grants Fund.

SECTION 2. Pursuant to Section 11(f) of the City Charter, the City Clerk is hereby directed to correct the budget records of said City for Fiscal Year 2021-2022 in accordance with the above modifications.

SECTION 3. The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.
