

**THIRD AMENDMENT TO THE
AGREEMENT FOR PROJECT SERVICES
BETWEEN THE CITY OF REDONDO BEACH
AND HARBOR INTERFAITH SERVICES**

THIS THIRD AMENDMENT TO THE AGREEMENT FOR PROJECT SERVICES ("Third Amendment") is made between the City of Redondo Beach, a Chartered Municipal Corporation ("City") and Harbor Interfaith Services ("HIS"), a California 501c3 Non-Profit Organization ("Consultant").

WHEREAS, on September 4, 2018, the parties hereto originally entered into the Agreement for Project Services between the City and HIS ("Agreement") whereby HIS agreed to provide Homeless Outreach and Housing Navigation services to people experiencing homelessness in the City; and

WHEREAS, on September 3, 2019, the parties entered into a First Amendment to the Agreement ("First Amendment") that extended the term of the Agreement for an additional two years to September 3, 2021 and the City donated a surplus vehicle and to provided additional compensation in the amount of \$20,000 for the maintenance of such surplus vehicle; and

WHEREAS, on July 21, 2020, the parties entered into a Second Amendment to the Agreement ("Second Amendment") that provided for COVID-19 expenses in the amount of \$28,400; and

WHEREAS, the parties desire to extend the Agreement that expired on September 3, 2021 for another three years to terminate on September 3, 2024 and to provide for additional compensation for each year of the extension.

NOW THEREFORE, in consideration of the promises and mutual covenants contained herein, and intending to be legally bound, the parties hereby agree to make the following amendments to the Agreement:

1. Term. Exhibit "B" of the Agreement is hereby amended to extend the term commencing from the date of expiration contained in the Second Amendment of September 3, 2021 and shall expire on September 3, 2024.
2. Compensation. Exhibit "C", section 1 of the Agreement is hereby amended and replaced with the following compensation provisions:
 - a) For services rendered pursuant to Exhibit A of the Agreement, Contractor shall be compensated in the amount of \$58,000 per year for a total not to exceed amount of \$406,000.
 - b) For maintenance of the donated surplus vehicle Contractor shall be compensated in the amount of \$10,000 per year, which

commenced September 3, 2019, for a total not to exceed amount of \$50,000.

- c) For quantified COVID-19 expenses incurred for services rendered pursuant to Exhibit A of the Agreement, Contractor shall be compensated in an amount not to exceed \$28,400.

3. No Other Amendments. Except as expressly stated herein, the Agreement shall remain unchanged and in full force and effect. The Agreement, the First Amendment, the Second Amendment and this Third Amendment constitute the entire agreement between the parties and supersede any previous oral or written agreement with respect to the subject matter hereof. In the event of any inconsistency between the terms of the Agreement, the First Amendment, the Second Amendment and this Third Amendment, the terms of this Third Amendment shall govern.
