

**Order Form Addendum**

This Addendum (the "**Addendum**") to Order Form no. 143356 by and between the City of Redondo Beach, CA, a Chartered Municipal Corporation ("**Customer**") and Zencity Technologies US, Inc., a Delaware Corporation ("**Zencity**"), dated as of March 18, 2021 (the "**Order Form**") is entered into as of October 19, 2021 (the "**Addendum Date**").

All capitalized terms not defined herein shall have the meaning ascribed to such terms in the Order Form.

**Whereas**, the Parties wish to amend certain terms of the Order Form as set forth herein;

**Now, therefore**, the Parties hereto agree to amend the terms of the Order Form as set forth below.

1. **Term**. The Term of the Order Form is hereby extended for a 12-month period commencing as of October 19, 2021, and ending on October 18, 2022 (the "**Renewal Term**"). At Customer's election, this agreement may be extended for two (2), one year terms. Customer shall give notice of its intention to extend the agreement, in writing at least 90 days prior to the end of such applicable term.
2. **Recurring Fees**. During the Renewal Term the Recurring Fees table included in the Order Form shall be amended and replaced in its entirety as follows:
