

#### **Overall Sentiment**








As noted in the administrative report for item H15, the lender request for Estoppel certificate is in part to receive assurance that "all obligations under the lease have been satisfied". But that is not totally true. Lease section 54, in compliance with Coastal Commission Development Permit 5-05-245, provides: " (b) ... Lessee shall reserve two slips within the marina for exclusive use by a non-profit equal opportunity sailing club, deemed acceptable by the Executive Director of the Coastal Commission ..."

The Coastal Commission has no record of ever being approached on this, much less of deeming the City of Redondo Beach (the slip assignee since 2007) to be a non profit sailing club. In my opinion transparent and scrupulous adherence to Coastal Commission agreements is the best City policy in general, and I recommend

that the City simply enforce this mandated lease provision as clearly written.
