#### **PUBLIC PARTICIPATION ON NON-AGENDA ITEMS** J.

Mayor Brand called for public comment via eComment and Zoom.

Holly Osborne, District 5, noted excerpts from an August New York Times article on how different areas of some cities were hotter or cooler based on the number of trees and green areas. She said the difference in temperature could be as much as 4 degrees on average of 8 to 9 degrees in extreme. She said the differences in these areas were traced back to redline policies of the 1930's and often the hottest areas of the cities were in poorer neighborhoods of people of color, with higher death rates and more health problems. She noted the article also pointed out temperature differences in cities all over the United States. She also noted National Geographics having a similar article on the importance of trees and inequities in cities. She expressed concern with a threatening policy in the future destroying the health of the neighborhoods with concretization. She said the policies are favorable to builders and speculators zeroing in on R1 zones, and said it is important to keep front yards where people can plant trees.

Motion by Councilmember Horvath, seconded by Councilmember Nehrenheim, to extend Ms. Osborne's time. Motion carried unanimously, with no objections.

Ms. Osborne asked that Assemblyman Al Muratsuchi introduce legislation that allows cities to preserve plantable areas and medians and oppose SB9 and SB10 and also pointed out that Senator Ben Allen is Chairman of the Environmental Committee.

Zein Obagi Jr. expressed concern with Council not looking out for North Redondo, and thanked Lyla Omora Garcia who got people into housing, and also asked that the City Attorney look into the agreements with Spectrum and Frontier relative to the maintenance and organization of their utility cords.

Chief Deputy City Clerk Vickie Kroneberger read the following comment via eComment:

Maggie Healey supported a community garden in Redondo Beach and urged Council not to provide any resources to the South Bay Parkland Conservancy without fully vetting that organization. She reviewed her concerns with the Conservancy and asked that the organization's activities be reviewed over the past three or more years with transparency to the community.

There being no further comments, Mayor Brand closed the public comment period.

#### L. PUBLIC HEARINGS

L.1. PUBLIC HEARING TO CONSIDER SUBSTANTIAL AMENDMENTS TO THE 2019-2020 AND 2020-2021 ANNUAL ACTION PLANS FOR REALLOCATION OF COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS AND ALLOCATION OF CDBG-CV3 FUNDS

Motion by Councilmember Gran, seconded by Councilmember Loewenstein, to open the public hearing. Motion carried unanimously, with no objections.

Interim Community Services Director Laurie Koike gave a PowerPoint presentation and discussed the following:

- CDBG-CV3 Funds allocation for \$453,481 approve by Council on October 6, 2020
  - \$300,000 for creation and management of temporary emergency shelters; addition of a housing navigator for North Redondo
  - \$110,000 for short-term assistance to small businesses through COVID-19 reimbursement grants;
  - \$43,481 for additional funds for increased planning and administrative costs
- Regular CDBG Funds
  - Reallocation of regular and previously unallocated CDBG program funds

#### Procedure

In response to Mayor Brand regarding \$75K available for allocations, Interim Community Services Director Laurie Koike stated \$30K of the \$75K will be used for the leasing of five rooms for a period of six months, with a remaining balance of \$45K.

In response to Mayor Brand, Finance Director Ruhland stated that CDBG funds do not have a December 30 deadline, which was for the state Cares Act funding.

Mayor Brand suggested allocating \$45K to Harbor Interfaith specifically for Redondo Beach residences experiencing homelessness.

Councilmember Nehrenheim supported Harbor Interfaith and helping those in need of housing.

Councilmember Emdee hesitated putting the entire amount towards a certain vendor due to things evolving and other vendors may need help.

Councilmember Horvath asked if there is anything specific regarding using the money for reimbursement.

City Manager Hoefgen stated the monies were left unallocated, noting three years to spend the monies. He suggested discussions with Harbor Interfaith to verify that they have capacity and ability to service the City, He also expressed concern with restricting the City which could create a problem later by only allocating the monies to one organization.

Councilmember Horvath also suggested costs going towards administrative help in processing information. filling out applications and paperwork.

Interim Community Services Director Laurie Koike stated staff will be coming back in a few months with the additional public service agencies and request for annual process. She also said working for one specific organization would require a proposal on how the funds would be used.

Mayor Brand suggested more funding will be coming in the next few months as well and said the \$45K is available now and should be used.

Councilmember Loewenstein supported Lila Omura who is very efficient and Harbor Interfaith is a worthwhile organization for funding. He also asked about the funding of a second housing coordinator to do the paperwork.

Consultant Damien Delaney suggested an email from Harbor Interfaith regarding how they would use the \$45K. He also said they are following Congress regarding approval of another stimulus package including state and local government.

Councilmember Horvath believed that the second housing coordinator was to focus on the same things that Lila Omura does specific to North Redondo.

Mayor Brand stated Lila Omura is covering both North and South Redondo without a second coordinator.

City Manager Hoefgen stated there have been discussions with Harbor Interfaith regarding a housing navigator for North Redondo and are waiting to hear back regarding staffing a position.

Councilmember Nehrenheim pointed out that Lila Omura has a partner with plenty of people in the background doing the paperwork.

Councilmember Emdee stated that Harbor Interfaith backed out of the five apartments for rental and now the City will have to go through another vendor. She said in addition, someone will need to do a census of all the homeless people in Redondo Beach. She said other vendors will be online and supported flexibility on the funding.

Mayor Brand informed that the City of Bellflower hired their own firm to do a more accurate homeless count.

City Attorney Webb recommended Council allocating the \$45K but not to a particular vendor, and said Lila Omura has become effective due to everything done over the last year and a half (reviewed). He didn't recommend Path but suggested City Net to do a homeless census.

Mayor Brand called for public comment via eComment and Zoom. There being no comments, Mayor Brand closed the public comment period.

Motion by Councilmember Gran, seconded by Councilmember Horvath, to close the Public Hearing. Motion carried unanimously, with no objections.

Motion by Councilmember Gran, seconded by Councilmember Horvath, to allocate the \$45K to homeless issues in Redondo Beach, and to consider substantial amendments to the 2019-2020 and 2020-2021 Annual Action Plans for reallocation of Community Development Block Grant (CDBG) Funds and allocation of CDBG-CV3 Funds. City Manager Hoefgen gave a report and discussed the following:

- Situation with the pandemic in Southern California has significantly worsened
- Stay at Home Order still in place at the state level
- ICU capacity dangerously low
- Bracing for more spikes
- Additional cases additional community spread
- New developments limited access to vaccines
- · Working closely with Beach Cities Health District
- Assist with education, further distribution of vaccines
- Cases in LA County and the City

Categories for individuals that can receive the vaccine

Mayor Brand advised that Lila Omura should be given priority for a COVID vaccination.

Jacqueline Sun, Beach Cities Health District, gave an update on the numbers as follows:

- Additional 13,512 cases in LA County today with 224 deaths
- Since the beginning of November, sharp increase in cases and deaths
- 400,000 cases in LA County beginning of December, 800,000 cases by the end of December
- Hospitalization and ICU's impacted
- 7,989 people hospitalized in LA County
- · Metrics prior to the spike and current surge
- Prioritization of the vaccines
  - Tier 1 in progress
  - Tier 2 in progress (Lila)
  - o Tier 3 in progress
  - o Tier 1 phases 1b and 1c

Tom Bakaly, Beach Cities Health District, gave a report and discussed the following:

- Draft of the vaccination strategy
- Goal provide education and accurate information regarding the vaccine
- · Resources in the Beach Cities
- Strategies
- Medical points of dispensing
- Testing
- Tiers and phases
  - 1A health care workers clinics, pharmacies, closed medical points of dispensing
  - o 1B older adults mobile strike teams helping with services
  - o 1C other essential workers closed medical points of dispensing, pharmacies
  - Phase 2 general public clinics and pharmacies, super pods
- Additional information Beach Cities Health District website
- Safe in the South Bay Panel February 4 from 5 to 6:30 p.m.

City Manager Hoefgen gave a report on the following:

- Reduce the fees for parking citations charged during street sweeping Council gave direction to explore
  reducing the fine to \$25 starting tomorrow direct cost to City of \$50K to \$60K per month this will take
  place on a month only Council can review on a month-to-month basis
- Suspend parking enforcement completely would create more problems and a larger cost
- Resolution will be brought back to next week's meeting

In response to Mayor Brand, City Manager Hoefgen stated with the reduction of \$25 for the entire violation, the City would only receive \$12, reducing the amount of monies the City would receive from parking violations by two-thirds.

In response to Mayor Brand regarding problems with the rainstorm, Public Works Director Semaan reviewed the impacts from rain and flooding, clogging the catch basins and/or into the screens, backing up and creating flooding issues.

Councilmember Nehrenheim stated he received a Moderna vaccine last week which was quick and painless and encouraged everyone to take the vaccine.

In response to Councilmember Nehrenheim regarding the City's allotment for vaccines, Fire Chief Metzger explained the process of administering vaccines and stated the Fire Department will be prepared to step in as needed.

Chief of Police Kauffman stated the Police Department has been speaking with the local EMS agency and believed that vaccines will take place in February, and there is authorization to allow the Fire Department to receive the dosage and administer to the Police Department.

Ms. Sun stated the Police Department is categorized in Tier 18 under the frontline essentials, and Fire is in Tier 1A due to health care workers. She also said Lila Omura would be categorized in Tier 2 of 1A, which is above the Police in prioritization.

In response to Mayor Brand, Chief Metzger stated the Fire Department would be administering the Moderna vaccine. He explained that the vaccine is allocated in vials and a rounded up estimate for the number of people or vials to be provided registered for any particular day. He said there would always be some surplus, since it is being rounded up. He also said Moderna is a two-dose series spaced 21 days apart, and noted an 83% participation rate in the Fire Department.

In response to Councilmember Nehrenheim regarding the phases, Ms. Sun stated the County Health Department determines who is in a particular tier with a distinct shift over to 1B which is a different population.

Mr. Bakaly said there can be some overlap and it is important to move through the phases.

Councilmember Nehrenheim also pointed out that there is a throw out factor with the vaccine going bad after opening the bottle which has to be used the same day. He also supported Mayor Brand live on Facebook on Thursdays at 6 p.m. with Dr. Marianne Gausche-Hill and said it is important to understand what is happening to the EMS system, the management and impacts. He further referred to parking enforcement during street sweeping and suggested continuing with enforcement but not ticketing unless there is an issue on a street.

Councilmember Loewenstein stated residents are concerned with the parking enforcement taking place during a pandemic, and cars having to be moved all day.

Mayor Brand called for public comment via eComment and Zoom. There being no comments, Mayor Brand closed the public comment period.

In response to Councilmember Emdee, City Manager Hoefgen stated the \$50K would be reduced revenue to the General Fund for parking enforcement which will need to be accounted for in the midyear budget report.

City Manager Hoefgen reviewed items for the January 12, 2021 City Council meeting to include both Closed Session and Open Session items, labor agreements with CEA and PSA employee groups, and compensation plan for management confidential employees. He also said a followup report will be included seeking Council input related to the Public Amenities Plan, and followup report and parameters for development of the inclusionary housing.

Councilmember Nehrenheim thanked Public Works for their help with the holiday lights in Torrance.

Councilmember Loewenstein asked people to stay safe and said help is coming.

Mayor Brand noted two complaints about the parking meter lights on the Esplanade and asked that they be turned down or off in the evening. Chief Kauffman stated there is no ability to dim them or shut them off but asked that the complaints be sent to him for review and possible mitigation.
