#### I. EXCLUDED CONSENT CALENDAR ITEMS

H.8. APPROVE AN AGREEMENT WITH THE CITY OF PALOS VERDES ESTATES TO ALLOW THE CITY OF REDONDO BEACH TO PROVIDE JAIL SERVICES IN THE AMOUNT OF \$290 PER ARRESTEE NOT TO EXCEED \$44,500, FOR THE TERM BEGINNING JUNE 1, 2021 AND ENDING MAY 31, 2022, OR UPON REACHING THE MAXIMUM REIMBURSEMENT AMOUNT, UNLESS TERMINATED BY EITHER PARTY.

At the request of Councilmember Nehrenheim, City Manager Hoefgen gave a report and stated after discussions, a mutually beneficial arrangement was reached.

Chief of Police Kauffman gave a report and stated the City of Palos Verdes Estates came back with a pressing need for the jail, parted out from the rest of the study, and came to the amount based on recovering the cost of personnel by booking their arrestees. He also said the City is very collaborative with the other agencies.

Councilmember Nehrenheim asked about the process. Chief of Police Kauffman explained instead of booking someone in Palos Verdes Estates once arrested, the officers would drive them here and book them into the City's jail. He also said any needs would be provided by Palos Verdes Estates but believed any medical needs or injuries would be provided by the City of Redondo Beach, and any long term injuries would go through the Workers' Compensation system. He said they would have to make other arrangements if the City of Redondo Beach wasn't available, and further said at this time most people are being cited out of custody or transported to the Sheriff's custody facility or post ball, being the same process for release.

Mayor Brand noted the City of Palos Verdes will no longer need a jail and expressed concern with the City of Redondo Beach being liable for injuries and other events. Chief of Police Kauffman stated the City Attorney looked into the insurance coverage that both cities have but said there is always a risk and supported cooperative policing. He also said the \$29,000 is a revenue estimate which will be in the upcoming budget.

Mayor Brand suggested being mindful of proper cost accounting. Chief of Police Kauffman also said the contract can be cancelled with a 30-day notice.

City Attorney Webb reviewed the section where Palos Verdes Estates indemnifies the City of Redondo Beach for willful acts and actions, but this was not the wording of the indemnification that staff wrote which was rejected. He noted this is a public safety benefit and the financial benefit is capped out at \$44,500 for a one-year agreement.

Councilmember Obagi asked how much the City of Palos Verdes Estates has gotten sued for police misconduct, etc. He also expressed concern with saving more money for the City of Palos Verdes Estates than what the City of Redondo Beach is making. Chief of Police Kauffman stated he didn't have this information but noted they have an excellent policing reputation.

Mayor Brand called for public comment via Zoom and eComment.

Chief Deputy City Clerk Vickie Kroneberger read the comment submitted via eComment by Lezlie Campeggi.

There being no further comments, Mayor Brand closed the public comment period.

Mayor Brand noted two indemnification clauses in the contract and expressed concern with risk.

City Attorney Webb suggested Council could recommend strengthening the indemnification language and go back to the first language drafted.

In response to Councilmember Obagi, Chief of Police Kauffman stated this particular item doesn't support the notion of the Police Department growing.

Motion by Councilmember Nehrenheim to approve for one year and to be reviewed in one year. Councilmember Nehrenheim withdrew his motion.

Councilmember Emdee suggested just doing a one-year cap to see how this will go, with the possibility of finding other ways with synergy and cost savings in other areas.

Motion by Councilmember Obagi, seconded by Councilmember Nehrenheim, to approve an agreement with the City of Palos Verdes Estates to allow the City of Redondo Beach to provide jail services in the amount of \$500 per arrestee not to exceed \$50,000 for the term beginning June 1, 2021 and ending May 31, 2022, or upon reaching the maximum reimbursement amount, unless terminated by either party.

Substitute Motion by Councilmember Emdee, seconded by Councilmember Obagi, to approve an agreement with the City of Palos Verdes Estates to allow the City of Redondo Beach to provide jail services in the amount of \$290 per arrestee not to exceed \$44,500 for the term beginning June 1, 2021 and ending May 31, 2022, or upon reaching the maximum reimbursement amount, unless terminated by either party.

Friendly Amendment by Councilmember Obagi that jail services be in the amount of \$325 per arrestee. Councilmember Obagi withdrew his Amendment.

Councilmember Nehrenheim asked about using CDBG funds and not taking on other cities.

Chief of Police Kauffman explained that no other cities are using the City's program and are people facing criminal complaints in the City of Redondo Beach being mitigated through Homeless Court.

City Attorney Webb gave a report regarding other cities and the goal is to have every city take advantage of a homeless court and pallet shelter based on the City's model, being a South Bay approach.

City Manager Hoefgen stated if there is a partnership agreement with one of the other cities, it could be specified where the money goes and what is being received.

Mayor Brand called for public comment via Zoom and eComment.

Jens Wessel supported the project, stated the City should look at the codes to be simplified and easier to interpret, suggested that the Planning Department go out to the project, supported the Sufnar's being consistent and opposed Mr. Stock videotaping children on Halloween. He also supported the Planning Commission and looked forward to a positive outcome and beautifying the Golden Hills area.

Greg and Jennifer Danielson supported the Sufnar family and their recent background improvements and stated they have been wonderful neighbors. They supported the project which has been tastefully done and questioned privacy issues only on the Sufnar's. She also noted an increase in value to the home and neighborhood and the Sufnar's being able to enjoy their home.

Mike Goldstein, District 3, supported the Sufnar family and the background improvements, reviewed their involvement in the City, and expressed concern with harassment from their neighbor which has a negative impact and asked Council to uphold the right decision.

Lisa Wessel submitted her strong support for the outdoor improvements done at the Sufnar home and valued the benefits. She also requested the City updating outdated codes and being easier to navigate. She also opposed the appeal, noting the Planning Commission voting 7-0 in favor for a backyard renovation.

Billy Errett stated the Planning Commission voted unanimously in favor of the project and reviewed the Sufnar's involvement in the City. He also expressed his support for the outdoor project and appreciated Council addressing this item. He pointed out that the Planning Code was not clear but the Commission delivered their best judgement with their approval of the project. He asked that Council uphold the decision of the Planning Commission.

Carrie and Bob Hayes thanked Council for their hours of service and said this process has been very challenging. She said they have been homeowners since 2001 and noted real estate going up in value and home improvements. She supported improvement in the City and the home of the Sufnar's.

Rolf Strutzenberg, Redondo Beach, stated he voted on the Planning Commission in favor for the blue structure being attached to the residence and said what he found in his research did not violate the code. He said what is built is clearly an accessory structure and not an accessory building, a 5 foot setback is required but there is an exception under 10-2.1522 to allow for the projections in the required setbacks for eaves and other similar items up to 30 inches from both the dwelling unit and the accessory structure and the height limit is 15 feet as defined in 10-2.1500C1. He also said under 10-2.402, accessory structures are not required to be detached. He said the Planning Commission's decision is in full compliance of the Municipal Code and encouraged Council to deny the appeal.

Kerry Bosse supported the Sufnar's and spending time outdoors and the backyard project which will increase the value of the home and enhancing the quality of life. She also believed this is a community improvement.

Jasmine Rassekh supported the project and outdoor living space, and believed the project is compliant with the City's Municipal Code. She also opposed harassment from the neighbor in the back, and believed this matter could have been resolved by the two neighbors.

Varina Moore, District 1, supported the Sufnar's and believed there is no issue with the structure, noted there will always be noise issues in Redondo due to density, expressed concern with the videotaping from the neighbor, and supported home improvements in the City.

Paige Howe supported the Sufnar's and their outdoor space, expressed concern with the neighbor filming and recording them, and noted many unkempt homes in the area and supported home improvements.

Chief Deputy City Clerk Vickie Kroneberger read the comments submitted via eComment by:

There being no further comments, Mayor Brand closed the public comment period.

#### Appellant Rebuttal:

Lisa Stock gave a history, reviewed letters of support and concerns, reviewed her concerns regarding the project and supported enforcing the laws and codes. She asked Council to correct the wrong, bringing the project into full compliance and issue citations for repeatedly and knowingly breaking the law while creating widespread animosity in the neighborhood.

### Proponent Rebuttal:

Matthew and Cory Sufnar reviewed incidents and complaints and not taking any action against the appellants. He stated the accessory structure fully complies to the Building Code and have made many attempts to find a solution that meets the needs of the appellants. He said the appeal is not a referendum on the permit enforcement process which are secondary to the true matter at hand and need to be tabled

outside the proceedings. He also reviewed letters of support. Cory Sufnar reviewed lessons learned and final closing and stated the project is in full compliance and asked for approval.

Mayor Brand stated he has never seen this conflict neighbor to neighbor going so far and can see why there was no settlement between the two neighbors. He also supported the presentations. He asked if this project is compliant with existing code.

In response to Mayor Brand, Community Development Director Brandy Forbes stated the accessory structure cannot be approved as an architectural feature because it exceeds the 9 feet in height and does not meet the code.

In response to Councilmember Obagi, Community Development Director Brandy Forbes explained that the bracket installed is a heavier support and meets the code. She also said there was an engineer doing the structural observations throughout the structure which has been documented and signed off that it is compliant with the code.

Councilmember Obagi believed an issue includes City Councils of past which didn't set up a City that was funded to enforce the laws and stop work orders. He also expressed concern with no stop work orders taking place and the project going forward anyway. He believed the neighbors became alienated from one another and stated Mr. Stock just wanted the law enforced and inquired about having permits. He also referred to statutory interpretation giving meaning to all words on the page and believed the accessory structure can be attached and is not required to have a 5-foot setback.

City Attorney Webb referred to accessory dwelling structures in residential zones and the general definition of accessory structures is essentially the building is detached and also accessory buildings are considered a subset of the code of accessory structures. He said the general rules apply to all zones and in this case, a dwelling unit and accessory structures have to be separated by 5 feet, regardless if they are detached or not.

Councilmember Emdee asked about the Masonry fireplace and earthquake concerns. Community Development Director Brandy Forbes stated this was reviewed by the Building Division with their structural engineer's observation documentation. She also said an architectural feature above 9 feet in height cannot be approved and is not permitted. She also said electrical in the roof structure is not approved but the gas line to the BBQ, to the fireplace, and structural for fireplace and replacement doors were approved.

In response to Councilmember Emdee, Community Development Director Brandy Forbes stated the options are reducing the height of the roof to 9 feet, or separate it 5 feet from the dwelling unit. She said the plans submitted were installing the BBQ and a fireplace which was submitted and already started the work and then a stop work order took place due to needing a permit and not submitting the full buildout.

Councilmember Loewenstein agreed that the language is misleading and should state structures as well.

In response to Councilmember Loewenstein what is considered the structure, Community Development Director Brandy Forbes stated it is the roof and fireplace and she believed it would be considered a roof. She also explained an eave which is at the end of a roof.

Councilmember Loewenstein referred to 10-2.1522 and believed the Planning Commission felt there was an exception, being a projection from a building, attached from a building as long as it projects out 30 inches from one end and 30 inches from the other end and they meet somewhere. City Attorney Webb clarified that the residential zones have a more specific requirement.

Assistant City Attorney Park clarified that the section was probably the basis for the Planning Commission's decision.

In response to Councilmember Nehrenheim regarding a variance, Community Development Director Brandy Forbes stated this would have to go to the Planning Commission and noted there are very strict criteria and unusual circumstances.

Councilmember Nehrenheim noted the trees are now gone and there are impacts to privacy and noise, and agreed with not impacting the neighbors. Community Development Director Brandy Forbes believed that planters were a requirement of the Planning Commission.

Councilmember Horvath asked about the architectural structure versus an accessory structure and the ambiguous language in the code. Community Development Director Brandy Forbes stated the accessory structure exceeded 5 feet and is attached to the building. She also said there are ways to clarify the language in the code but the bigger issue is lifestyle changes. She further said the residential design guidelines are outside of the zoning code itself. She said there were many restrictions and access during the pandemic and said precautions were taken. She further did not believe anything intentional took place regarding gaining the system but said the drawings showed something different when they came in.

In response to Councilmember Obagi, City Attorney Webb stated tonight's meeting is not about enforcement and is simply to make a determination on the appeal from the Planning Commission.

Motion by Councilmember Obagi, seconded by Councilmember Horvath, to close the Public Hearing. Hearing no objections, Mayor Brand so moved.

Councilmember Horvath stated communication is important between contractors and residents, and noted ambiguity in the code language is the main issue regarding tonight's hearing.

Councilmember Emdee reviewed her concerns to include staff telling the Stock's to take pictures, communication issues, lack of code enforcement and not following rules.

Councilmember Nehrenheim pointed out that the trees will remain in place and grow to a large size to absorb the sound and increase privacy to neighbors in the back.

Mayor Brand asked about the electrical. Community Development Director Brandy Forbes stated the BBQ, gas to the BBQ, the fireplace and structural for the door replacement have been permitted but there is electrical in the roof of the accessory structure which has not been permitted but are installed which will need to be inspected.

City Attorney Webb advised that Council review the Resolution before making a final decision on the motion.

Councilmember Emdee also pointed out that there are two televisions in the back yard and tile on the floor which could be extremely noisy for the Stock's and suggested deadening the sound.

Councilmember Emdee and Mayor Brand expressed concern with being able to enforce the trees, causing a conflict.

Motion by Councilmember Horvath, seconded by Councilmember Loewenstein, to adopt by title only Resolution No. CC-2105-044 denying the appeal and upholding the Planning Commission's decision for approval, including under Conditions, #2, requiring a minimum of six trees of the applicant's choosing, and under Findings, item "b" to read "Per criteria (1) for Administrative Design Review, the proposed accessory structure's roof complies with the provisions of Title 10 Chapter 2 as set forth in Section 10-2.1522 projections in the required setbacks." Motion failed, with the following roll call vote:

Motion by Councilmember Horvath, seconded by Councilmember Emdee, to open the public hearing. Hearing no objections, Mayor Brand so ordered.

City Manager Hoefgen gave a staff report and timeline, noted BRR's in the packet, and asked Council to provide any additional BRR's tonight.

Councilmember Horvath requested an expansion onto the BRR regarding the dog run facility and existing dog parks for similar type structures at McNeill JC, Franklin Park and Lilienthal Park.

Councilmember Nehrenheim asked about the status on Knob Hill stairs between Esplanade and the bike path regarding the lighting. Public Works Director Semaan stated this is part of BRR #2, Lighting along beach access and pedestrian walkways.

Councilmember Nehrenheim asked about the balance of Quimby Fees. Assistant City Manager Witzansky stated there is approximately \$600K in estimated revenue with \$450K of planned uses with some additional carryover, with a projected yearend balance of approximately \$200K. He said staff can provide a breakdown.

In response to Councilmember Nehrenheim, City Manager Hoefgen stated with covid restrictions, the Veteran's Park library was unable to operate and an RFP to solicit another operator will be coming to Council.

In response to Councilmember Nehrenheim, Assistant City Manager Witzansky stated Council will be able to discuss the dog park project as part of a CIP along with the nonprofit.

In response to Councilmember Nehrenheim, City Manager Hoefgen referred to the PAC position layoff which was not part of the Council's motion and was a permanent action, and there are still some positions being held vacant for a year.

Mayor Brand referred to DP #6 and suggested funding from a different source. He also requested a breakdown of both the acquisition fund and the Quimby Fees.

Councilmember Loewenstein asked about the estimate for stepped up code enforcement, requested a BRR on phase 2 of accounting fire study, requested a BRR regarding dollars saved by combining fire chiefs with Manhattan Beach and El Segundo, asked about the cost of the chevy suburban in BRR#3, asked for a breakdown regarding the costs of equipping the vehicles versus buying them off the street, and requested reviewing the ending balance after approval of the DP's July 1, 2022 which currently reads \$8.4M.

Councilmember Obagi suggested an area with a walkway on either side for a dog run and asked about a BRR regarding funding an enforcement program and administrative hearing.

City Manager Hoefgen stated an update on options for funding code enforcement services will be provided. City Attorney Webb suggested providing a list of code sections.

Councilmember Obagi requested a BRR on the North Redondo Bike Path and bulb outs on Grant Avenue and cost estimates on parking spaces.

In response to Mayor Brand regarding the street sweeping parking fine, City Manager Hoefgen stated the City is now back to regular enforcement and fine levels.

Mayor Brand suggested installing parking meters along Francisca between Herondo and Catalina. Assistant City Manager Witzansky stated this is in the current budget and parking resolution (DP#43).

Councilmember Loewenstein requested a breakdown on the number of spaces that would be metered at each location.

Mayor Brand called for public comment via Zoom and eComment.

Chief Deputy City Clerk Kroneberger read the comments submitted via eComment by:

There being no further comments, Mayor Brand closed the public comment period.
