Fire Division Chief Jason May narrated a PowerPoint presentation of recent fire events in the City including a Department Evaluation and Tri-Cities Administrative Sharing, response activity, harbor special event permits; addressed safety tips for the month of May and discussed recent tests of the Tsunami Alert System at Torrance Beach.

Discussion followed regarding the maintenance schedule for home fire sprinkler systems, increases in call volumes across Beach Cities and procurement and sharing of auto-pulse equipment.

Officer Lofstrom addressed vacancies and staffing in the Harbor Unit.


Discussion followed regarding the process for filling the current vacancy in the Public Safety Commission.
