J.1. For eComments and Emails Received from the Public

Nikki Negrete-Mitchell, District 3, thanked Council for its support and commitment; discussed the Metro project and possible negative impacts to residents of Redondo Beach; encouraged residents to attend the upcoming Metro presentation at Adams Middle School and provide feedback on the alternatives.

Holly Osborne, District 5, discussed ADUs and zoning laws that were passed 2020; commented on apartment owners converting garages into ADUs thereby removing parking and spoke about another project where five garages are being converted into ADUs.

Motion by Councilmember Horvath, seconded by Councilmember Obagi, to extend the time for Ms. Osborne's comments. There being no objections, Mayor Pro Tem Nehrenheim so ordered.

Ms. Osborne spoke about educating the public on zoning initiatives and another bill in the works, SB 897 and discussed contacting legislators to encourage their opposition.

Lisa Rodriguez spoke about elected officials representing the constituents and open and fair discussions and decisions-making; discussed Council's approval of a special election on October 19, 2022 at a cost of \$297,000 instead of placing the initiatives on the November 8, 2022 general election at a cost of \$36,000; believed it is not only fiscally irresponsible, but violates the public's rights in participating in the decision-making process; alleged a conflict of interest by Councilmember Obagi and urged Council to withdraw the October 19, 2022 special election, allowing Recall Obagi on the November election.

Eugene Solomon spoke about the process when emailing the District Attorney's Public Integrity Unit with concerns.

Nancy Skiba, District 4, speaking on Item No. H.6., voiced support for the use of military-style equipment by the Police; spoke about a recent incident at a business location on Artesia and thanked the Redondo Beach Police Department and the SWAT Team Unit for supporting and keeping residents, safe.

Chief Deputy City Clerk Vickie Kroneberger read eComments from Barbara Epstein, Vicky Oetzell, Maggie Healy, Deepti Kannapan and Lezlie Campeggi.

City Attorney Webb introduced the item and Quality of Life Prosecutor Joy Ford.

Quality of Life Prosecutor Ford provided an overview of enhanced responses to homelessness grants; noted the City will be awarded over \$1.7 million in grants towards its efforts to reduce homelessness; discussed other grants received including pallet shelter grants; requested direction from Council on whether to continue the pallet shelter program for another year; addressed sources of funding; spoke about capital improvements to the pallet shelters and reduced costs; reported her office is looking into a permanent housing allocation distributed by the California of Housing and Community Development; mentioned the \$50,000 provided by BCHD and listed recommendations.

Discussion followed regarding water and sewage on site, CDBG funds, the timeframe on spending the funds, completing the work by October, changes in crime along the site of the pallet shelter, calls for service, areas from which pallet shelter residents come, the number of homeless in Redondo Beach, other suitable sites in the City for a pallet shelter, extending the program for one year, the possibility of locating a pallet shelter on the BCHD site and ownership of infrastructure and equipment.

Mayor Pro Tem Nehrenheim invited public comments.

Rolf Strutzenberg spoke about a recent community meeting where a representative of Project Homekey reported Redondo Beach was chosen for Project Homekey because of the existing homeless including the pallet shelter and homeless court.

Valerie, former Pallet Shelter resident, shared her experience at the facility; spoke about how it positively affected her life and hoped Council will extend its operation for another year.

Motion by Councilmember Horvath, seconded by Councilmember Emdee, to extend the speaker's time for comments. There being no objections, Mayor Pro Tem Nehrenheim so ordered.

Valerie reported she is clean and sober, has a job, has her own apartment and feels supported.

Councilmember Emdee commended Valerie for her courage in sharing her story.

Mayor Pro Tem Nehrenheim thanked Valerie for humanizing and sharing her story.

Councilmember Obagi expressed his appreciation as well.

Nikki Negrete-Mitchell, District 3, commended Lila and City staff for their help; spoke about the homeless programs being well organized; questioned why anyone would want to move the pallet shelter as the program is working so well and shared that her brother passed away, homeless.

Eugene Solomon quoted Mohamed Ali; thanked the City for its efforts; noted that operational costs were all hard costs; spoke about soft costs including raises to the City Attorney's team working on the programs, vehicles and new hires and indicated he would like to know what those expenses have been during the operation of the temporary transitional housing.

Ramon Rendon, Harbor Interfaith, noted the team is working hard on homelessness; stated the programs the City has put together is admirable; indicated it is a golden model of what each city in California should use; discussed providing wrap-around services and encouraged Council to visit the shelter.

Christina Miller, via Zoom, District 3, commended the City for the success of the homeless programs; hoped Council will build upon the City's successes; spoke against moving the pallet shelter to another site and thanked the City for its humane approach.

Carrie Ann Larson, via Zoom, Chief Program Officer for the BCHD, spoke about expansion of their service agreement for fire services and the domestic violence advocacy program; discussed having a pool of funds for homeless services and commended the City for its proactive program that is making a difference and serving as a model to other communities.

City Clerk Manzano read an eComment from Vicky Oetzell.

Councilmember Horvath thanked the team for the success of the programs and commented on the continued growing need for services and on the soft and hard costs.

Councilmember Obagi thanked everyone for their work in providing services for the homeless.

Councilmember Emdee spoke about the big picture in terms of all the people contributing to the homeless programs; noted relocation of the pallet shelter is not part of the discussion and stressed this is not a permanent program.

Mayor Pro Tem Nehrenheim commented on the soft costs and noted the need to be cognizant of them.

N.2. DISCUSSION AND POSSIBLE ACTION ON THE COORDINATION OF CITY VOLUNTEER OPPORTUNITIES

CONTACT: CAMERON HARDING, COMMUNITY SERVICES DIRECTOR

City Manager Witzansky introduced the item and deferred to Community Services Director Cameron Harding for a presentation.

Community Services Director Harding narrated a PowerPoint presentation regarding coordination of City volunteer opportunities; addressed current practices, creation of a volunteer webpage and a dedicated email and noted staff will continue to explore other avenues to enhance coordination.

City Manager Witzansky spoke about being a conduit to connect volunteer groups in the community to volunteer projects that are available at any given time.

Discussion followed regarding opportunities to free up staff time, targeted areas within the Community Services Department such as recreation and parks, senior services and Section 8, the possibility of expanding the Recreation and Parks Commission and creating volunteer opportunities.

Councilmember Obagi suggested creating volunteer and intern opportunities for the City's youth.

Mayor Pro Tem Nehrenheim opened public comments.

Lisa Rodriguez spoke about her experience with volunteering and cautioned the City about volunteer organizations that may exploit and suggested vetting organizations as well as volunteers, especially if they are involved in political action committees.

Eugene Solomon stated that asking that community organizations not have a political action committee that would disqualify them is a political request; noted there are a number of organizations that have packs and commented on the vetting process.

Rolf Strutzenberg spoke about the possibility of coordinating the program with the Career Technical Education program through the California Regional Occupation Center or the Redondo Beach School District.

Sheila Lamb, via Zoom, District 4, thanked Councilmembers and City staff for starting the program; supported the webpage; suggested getting various groups together at Seaside Lagoon to honor their work and to show that the City values community engagement.

There were no other public comments on this item.

Motion by Councilmember Emdee, seconded by Councilmember Horvath, to receive and file a report on the plan to coordinate the City's various volunteer opportunities. There being no objections, Mayor Pro Tem Nehrenheim so ordered.
