John Nolen spoke in favor of the safety analysis but not in support of parking removal. The impact is higher in the morning and later in the day when school starts and ends. Suggested if the church could open their parking lot for residential parking when not in use by the church for services.

Civil Engineer Sanders confirmed that there were no eComments or public comments received.

Seeing no additional requests to speak, Chair Simpson closed the floor to public comments.

Discussion followed regarding the suggested changes in front of the church, apartment and residential parking availability, reallocation of the three parking spaces removed, further research before making a decision, school zone safety, and history of collisions.

A friendly amendment by Commissioner Bajaj to include if the Church does not accept the decision from the Public Works Commission that the request is denied.
