3. QUARTERLY REPORT SUBCOMMITTEE

Chairperson Gaul asked how to measure the Public Safety improvement in the City of Redondo Beach? There is a lot of data out there, who is for and how does it make our lives better? Study called Safe Wise, a consulting firm in Utah, they use FBI crime data. When looking at the data, it was property and physical crime. This KPI was used to rate cities and showed year over year improvements in cities but is the gold standard for City of Redondo Beach to market to reduce crime rates. What will it take to move the needle to the rate of Rancho Palos Verde? In the report, Manhattan Beach ranked 1 worse than Redondo Beach in crime. What tools does the police need to improve the metrics for a demonstrated result, what type of budget items, and staff changes? Asked the Commission if anyone is interested in talking off line about this and if this is useful?

Commissioner Hannon believes in metrics but how will we know if it will make the community safer unless we have a before and after, we have to have a baseline. He is sure that the Police Department has metrics that they must monitor and would love to see those. Very familiar of Swithers data, what is happening on the streets, serious injuries and fatalities, it is national data

that is reported annually. Organization Commissioner Hannon is part of, creates report cards for each city in the South Bay and measures each of the Cities. Reports safety records for bicyclist, pedestrians, and people who participate in active transportation. Thinks this information is useful as one of the metrics and is willing to share what the organization does. How do other rank cities in the United States? Usually based on livability, an exuberated quality of life. One of them is safety, how many burglaries happen on our streets. Encourage to make a motion to look at this group and see what police metrics we have, Swithers data, and livability data, see if we can register the difference.

Commissioner Gupta stated that within his work, they keep track of data. If metrics are tracked every month, then the data can be reviewed internally. Then someone can come in and develop interventions.

Chairperson Gaul spoke on the Safe Wise data and how the cities keep their rank year after year. Baldwin Park went up in rank and is interested to know what their city is doing. Interest in scheduling a data analysis review at some point that Commission or staff provides. Officer Lofstrom stated that specific metrics are found on the City website.

Motion by Chairperson Gaul, seconded by Commissioner Gittens, in the March meeting to have staff provide a series of trend data and FBI crime data from the last 5 years in the agenda along with any other Commissioners data. Motion carried unanimously, by roll call vote.

5. HOMELESS SUBCOMMITTEE

Chairperson Gaul commented on the LA-HOP organization. If you see a homeless person in your community and are able to describe the person, you may go online and fill out an outreach request instead of calling the police. The outreach workers have: homeless services navigation, mental health training and first aid, post-trauma inform care, and some teams have physical and mental health professionals. Main goal of the program is to get people off the street and into a permanent home.

Commissioner Gupta requested for the LAHOP organization to attend a Public Safety meeting and asked if the Commission has the ability to publicize LA-HOP.

J.2. DISCUSSION OF RECENT FIRE EVENTS

Chief Yang introduced himself and spoke about his experience in the fire department.

Chief Yang began his report with medical aid calls, 694 from November 2021, 290 of the call were fire based (structure fires, unsafe wires, and smoke alarms). 729 emergency responses in December 2021, 483 of those calls were medical, 246 fire emergencies. 5,300 calls a day in 2011, 7,598 in 2022, running 15 calls a day in 2011, now running 21 calls a day. Medical aid is the significant calls of responses. 3,100 calls from the station one on Broadway a day, 3,536 calls from station two, 869 calls from station three. There is a consistent number of increases in call volume throughout the year. 2020 was an outlier year of over 7,000 calls and from March to June ran a 30% call volume because people were not wanting to go to the hospital. Escalation in

volume in December 2021 with 7,600 calls. An equipment called the auto pulse is used for those that are found without a pulse but not breathing. A trial was made from November 2020 to November 2021, the conversion for compressions in the field is 30% - 65%. Expanding a community engagement campaign in 2022 regarding this technology.

Commissioner Gupta commented that this technology is amazing. Asked if the device does the chest compression?

Chief Yang replied, yes. Briefly explained how the device works, up and down motion on the lower part of the sternum and there is a band that goes around the entire torso.

Commissioner Gupta asked if the defoliator is attached?

Chief Yang replied, that it is applied separately.

Chairperson Gaul asked Chief Yang what is the cost for this system?

Chief Yang responded, the device itself with the batteries and other equipment is about \$20,000. The device is resilient and has an extended warranty.

J.4. DISCUSSION OF RECENT LAW ENFORCEMENT EVENTS/CRIME RECAP

Steven Cagle from the Core Center Organization began his presentation.

- Curtis Tucker Community Center
- Part of Department of Public Health/Substance Abuse Prevention and Control (SAPC)
- Main goal is to educate, connect, and provide prevention services to LA County
- Collaborative program located throughout the county. Services are free to the public
- Services: prevention, workshops, support (hotline), opioid overdose
- Different educational workshops: Understanding the Connection Between Sud and Mental Health, Understanding the Risk of Cannabis, Recognizing and Responding an Overdose with Naloxone, Substance Use in Your Community, How to Talk to Your Loved Ones About AOD, Relapse Prevention and Healthy Coping, Stigma and Substance Use Disorders, Teens and Vaping.

Steven and Krystal opened the floor for questions.

Chairperson Gaul told Steven and Krystal that it is a pleasure to have them at the Commission meeting.

Roman Rardon from Harbor Interfaith has began his presentation.

- Community members would send out a LA-HOP request which then would go to Roman directly.
- Roman would then dispatch to an outreach worker.
- Lead agency in SPA 8
- Redondo Beach contract started in 2017
- Beach Cities contract started 2019
- Roman started as an outreach worker for the Organization
- Collaborate with substance abuse programs, police department, fire department
- Many programs collaborate to get homeless into shelters

Roman end his presentation.

Chairperson Gaul liked the data in their reports. Mentions the terrible event in Redondo Beach of a person that passed away from overdose. Raised a question on tracking the number of homeless in the last 5 years and is there overdose data available in Redondo Beach?

Roman responded that when it comes to the number of homeless in Redondo Beach, there is a Homeless Count coming up. Last year Redondo Beach contracted with a homeless service provider that has numbers on city net.

Krystal also responded to Chairperson Gaul's question, regarding the overdose, she was not aware of any statistic but she can look into it. She is doing a presentation in February with Hermosa. She knows that the police department did an undercover assignment where they bought some pills.

Commissioner Marinelli thanked the presenters for their time and making a difference in the community.

Commissioner Gupta told the presenters they are doing amazing work. Raised a question about interventions targeted toward schools.

Steven responded, that they have started and trying to target more of that demographic. There was panelist from the high school that were educating the other students at the school. Teens are being affected more than ever before.

Krystal also responded that the program is interested in expanding and that the program just started during COVID.

Commissioner Gupta asked Chairperson Gaul if the Commission can help schools or have any connections as a Public Safety Commission.

Chairperson Gaul replied that he tried to connect with schools on the Historical Commission. There is not much of a connection on the Commission to school level. Asked Commissioner Gupta to send an email to the schools on behalf of the Public Safety Commission.

Commissioner Hannon, commending Steven Cagle and Krystal's services. Shared an experience working with students in Hermosa Beach creating public service announcements, suggested to urge the schools to do the same. Commissioner Gupta, agreed with the Commissioner Hannon's idea. Commissioner Gupta ask Officer Lofstrom if there is data of overdoses among students in Redondo Beach.

Chairperson Gaul, raised a question to staff if the Police Department has access to Channel 3 to broadcast homeless support and over dose intervention. Officer Lofstrom responded that the Police Department has no connection.

Officer Lofstrom began his presentation:

- Call for service report:
 - October to November an 8% increase in calls for service, 16% increase from last year
 - November to December 14% increase, 7% decrease from last year
 - November to December 3,300 citizen calls, November 2200 officer contacts, December 1500 officer contacts
 - November crime activity such as theft from vehicles, 2 robberies, 2 arrest, 3 reports of stolen catalytic converters, Redondo Beach/Torrance storage facility had recurring burglaries

Chairperson Gaul raised a question on using a bait car for the catalytic converters. Officer Lofstrom responded that the option is an expensive one although there is a bait bicycle. There will be more Etching events for the public.

Officer Lofstrom continued his presentation.

- Calls for service went down in December.
- Street racing activity
- Crimes against persons with a deadly weapon, suspect fled, used officer and K-9 resources to search for the suspect and was able to capture the suspect after several hours.

Officer Lofstrom ended his presentation.

Commissioner Hannon commend Officer Lofstrom's presentation and that Officer Lofstrom's report contained a lot of information. Officer Lofstrom responded that the crime analyst prepared most of the information. Property crime is the highest level of crime in Redondo Beach.

Commissioner Marinelli: Due to his career, Commissioner Marinelli is unable to be part of the Homeless subcommittee but is interested in being a liaison for the Publics Works and businesses near the Harbor. Officer Lofstrom responded that he will connect with units near the Harbor and contact Commissioner Marinelli if there will be a meeting.

Commissioner Klainbaum: None

Commissioner Gittens: None

Commissioner Gupta: Interested in working with schools and asked if Staff has any data or resources on overdose. Officer Lofstrom responded that staff information contains bicycle legislation, overdose data, and 5-years FBI crime data.

Commissioner Hannon: Impressed with Officer Lofstrom report, specifically stopping a crime from happening early on. Spoke to Chief Kauffman about being the first in California to have a diversion (traffic school). The procedure for a bicyclist that received a citation may have the opportunity to go to traffic school, earn a certificate, present the certificate to a judge and have their citation removed from their record. Interest in hearing the Staff's feedback about the program. Officer Lofstrom responded that his main duty is a K-9 handler but has done traffic enforcement before. The City's Safety Element is a state-required General Plan Element that identifies potential natural and human-created hazards that could affect the City of Redondo Beach's (City's) residents, businesses, visitors, and services.

Sean Scully, Planning Manager, thanked the Commission for having the Special Meeting for this item. Started the presentation:

- Safety Element – Background/Overview
 - 7 required Elements: Land use, Circulation, Freeway, Open Space, Conservation, and Housing
 - 1992 was last safety element and is due for an update.
 - Incorporates hazard and safety elements.
 - Vulnerability assessment to test the impacts of climate change
 - Elements set the foundation of how to handle disasters in the City
- Purpose of the Safety Element
 - Identify and address natural and human-caused hazards existing in/or near Redondo Beach
 - Functions: As projects come into the City they have to make sure the goals and policies are followed; every policy is required to have a limitation program but do not have them ready for the safety element yet; strengthen hazard preparedness

planning and post-disaster reconstruction policies; identifies how hazards are likely to increase in frequency and intensity due to climate change

- Required by State law to have 6 sections
 - Emergency Preparedness, response, and Recovery
 - Geologic and Seismic Hazards
 - Flooding and Sea Level Rise
 - Hazardous Materials
 - Fire Hazards
 - Additional Climate Change Hazards
- Components
 - Relation with other public health and safety documents: Vulnerability Assessment, Redondo Beach Local Hazard Mitigation Plan, and City's COOP and Emergency Operation Plan
 - Relationship with other General Plan Elements: Land Use Element, Open Space and Conservation Element, and Transportation and Circulation Element
 - All general plan elements have to be internally consistent with one another.
- Staff Edits: Continuity of Operations Plan and Emergency Operations Plan
 - Sean Scully and Isaac Yang reviewed this section that is presented. The words crossed out was removed and the words highlighted was added. Staff does not have either a Continuity of Operations Plan or Emergency Operations Plan but this element has a policy and a goal.
- Staff Edits: Strategic Efforts
 - Replacing a location with the Main Library, Second floor.
- Staff Edit: First Rule and First Policy
 - Replacing a policy that is presented with the highlighted sentence.
- Goal SF-1
 - Sean Scully asked the Commission what they want edited from this section that is presented
 - Sean Scully read aloud the goal.

Sean Scully opened the floor for comments and suggestions

Commissioner Couig raised a question to the Commission, if all Commissioners have reviewed the section prior to the meeting. Chairperson Gaul responded that he did not focus on this goal and that this is the first time and asked the Commission if they have any suggestions for edits. Commissioner Hannon raised a question to Sean Scully if it states anywhere in this section that residents will engage in mitigation. Sean Scully responded that there are no components that states specifically but only to educate the public. Chairperson Gaul suggest to include; increase and involve the public to participate for emergency response planning procedures Commissioner Hannon suggest to add "engagement" to the wording. Commissioner Couig commented that this is a policy not an implementation of what is to happen and if a disaster were to happen, groups would engage and a plan will be made. Commissioner Hannon asked for Isaac Yang, Fire Chief, to give his input is a disaster would happen. Isaac Yang responded, relative to the conversation, first action is to take care of yourself, your family, your neighbors, and secure your safety. First call out would be the alumni group and there would be staging areas set up. A staging area specific to resourcing people based on their ability and capacity to be able to assist in control spaces such as administration and rehabilitation. Isaac Yang continued, if there were at least

1,000 alumni responders to cover 1,000 blocks then it would be of tremendous assistance. Commissioner Hannon asked Issac Yang if the information he shared should be in the policy. Issac Yang suggested to Commission to add language of increase public awareness of potential participation in an emergency response.

Sean Scully read aloud the new language to add the policy: increase awareness in emergency response planning and procedure to include public engagement.

Sean Scully continued with his presentation.

 - Chairperson Gaul raised a question, if 19-33 structures were part of the previous structure.
 - Sean Scully responded, is not aware of those facilities in the City.
- Hazard and Emergency Data
 - Establish a data base in GIS
 - Chairperson Gaul asked if this system is update. Sean Scully confirmed the system is up to date.
 - Commissioner Hannon raised a question on flood insurance west from PCH, is there anything specific plan to control that. Sean Scully responded that reports would build up to create the database for certain locations and informs staff to preform studies and inform staff of high-risk areas. Commissioner Hannon replied, there is both consequences and likelihood, the consequence are high risk for those that live in that area that this requires special attention. Commissioner Couig responded that the policy requires what Commissioner Hannon was referring to and reminded that this is only a policy.
- Goal: Seismic and Geological Hazards
 - Reduce death, injury, property, damage, economic and social dislocation, and disruption of vital resulting from seismic and geologic-related events.
 - Making individuals aware of what faults are near
 - Commissioner Couig, if there already gas shutoff earthquake sensors. Issac Yang responded, the policy is referring to occuppies such industrial facilities.
- Goal: Tsunami Hazards
 - Protection of life from tsunami run.
 - Chairperson Gaul, what are specific measures that are easier to implement. Sean Scully, there would be a variety of different of situations and different measures for those situations and then find funding. Improving warning of tsunami is important. Chairperson Gaul, is there a connection to Channel 3 to help warn the public. Sean Scully, Community Services Department has access to communicating to the public. Issac Yang speaks of ways to communicate to the warning the public and how time is valuable.
- Goal: Flood Hazards
 - Protection of life of floods
 - FEMA updated information flood hazards zones
 - Make sure we are aware of the locations that are potential flood hazards
- Goal: Sea Level Rise

- Safeguarded and adaptively managing for rising sea levels
- The next waterfront project will incorporate this policy
- Commissioner Hannon, identification of different issues in future plans. Sean Scully confirms Commissioner Hannon's comment.
- Chairperson Gaul, how will the pier constructed to be more resilient? Sean Scully, the Public Works Department are consistently working on trying upgrade the pier. Chairperson Gaul, recommended to hire an individual to work on grants to fund the projects.
- Goal: Hazardous Materials
 - Cannot accept applications without looking for the hazardous materials.
 - Redondo Beach has hazardous materials such as oils that have to be mitigated.
 - Make sure the small amount of ground water we have does get clean.
 - Commissioner Couig commented on the dry cleaners that are under evaluation. Sean Scully, the chemicals the dry cleaners use can be toxic.
- Goal: Fire Hazards
 - Issac Yang led the discussion for this slide.
 - Minimize risk of injuries.
 - New regulations include fire hazards.
- Goal: Additional Climate Change Hazards
 - Resilient community able to adapt climate change hazards
 - Drought conditions are more common.
 - Commissioner Klainbaum, refer to policy 10.7, if it is referring storm runoff reduction or collection. Sean Scully confirmed it is referring reduction. Commissioner Klainbaum asked if there is a policy for storm runoff collection. Sean Scully, some establishments are required to have storm water mitigation, low impact development involve retention. This information is currently in an ordinance.
- Bring the draft and edits General Plan Advisory Committee, then the Planning Commission, and the City Council.
- Land use plan need to be completed before taking the Safety Element Plan the Planning Commission.

Sean Scully ended his presentation and asked the Commission for comments or questions. Commissioner Klainbaum raised question, the emergency center locations are all on the same block. Sean Scully, the locations is where there are now. Issac Yang, the immediate functionally of the police station emergency location is serve the community in that space but if the incident expands then they will move into the library facility. Commissioner Klainbaum, ask staff to consider expand the locations to different areas. Commissioner Couig, suggest back up locations if the need arises. Commissioner Klainbaum, suggested measuring the goals objectively so there is a benchmark. Sean Scully responded, that level of detail would be attached as an appendix. Sean Scully took note of the backup plan for other emergency center locations. Issac Yang, any space that able to assemble can be utilized.

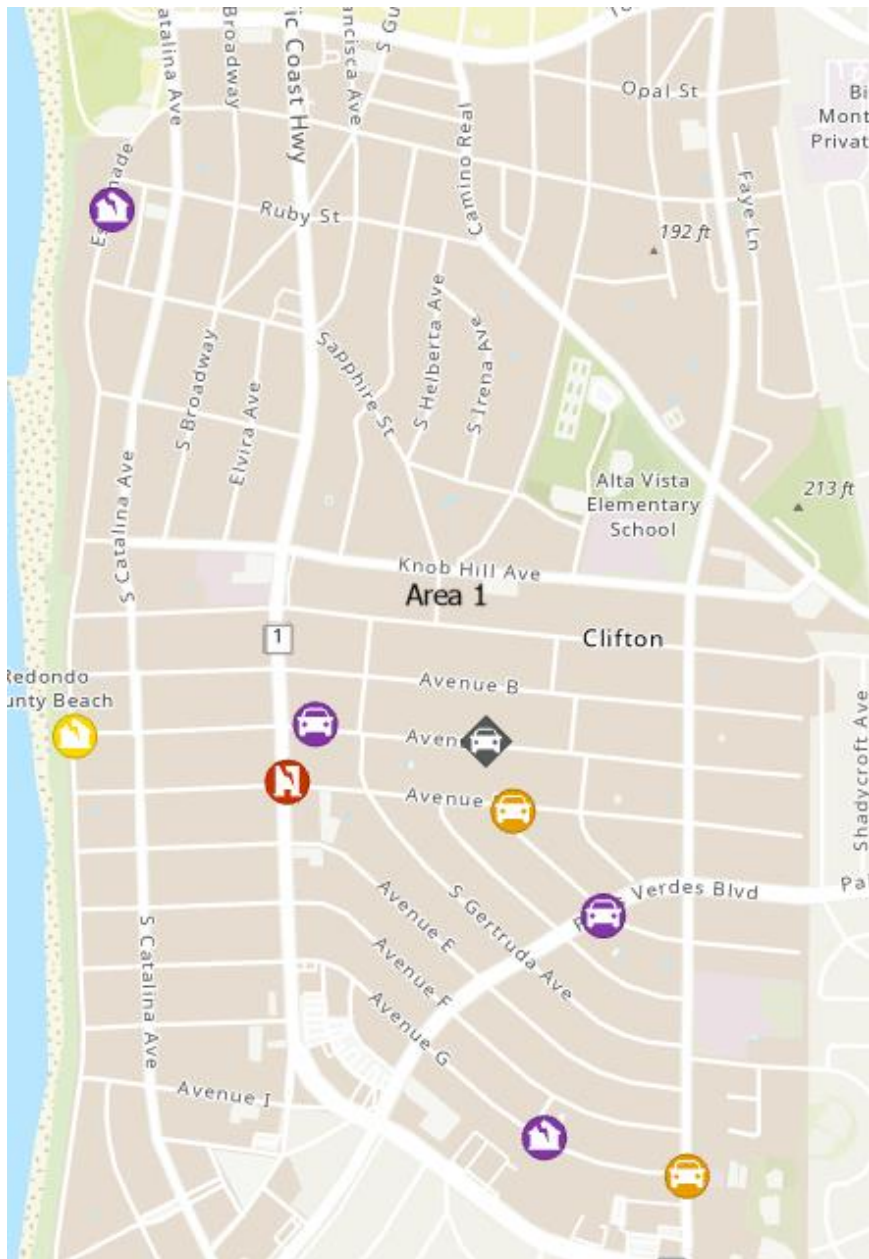

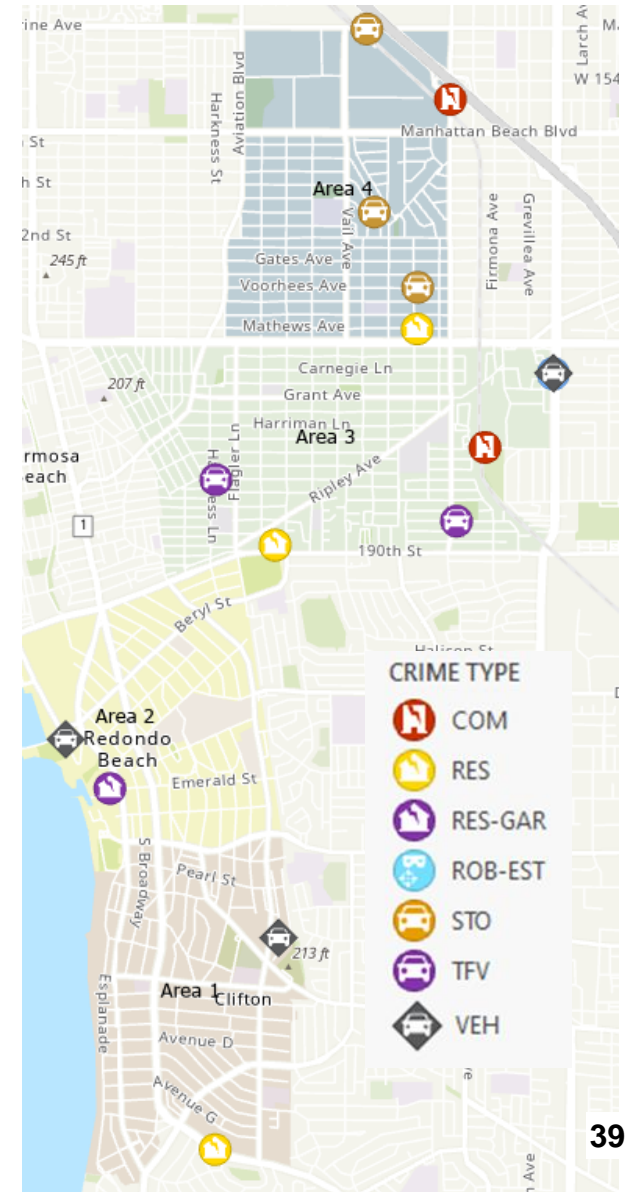

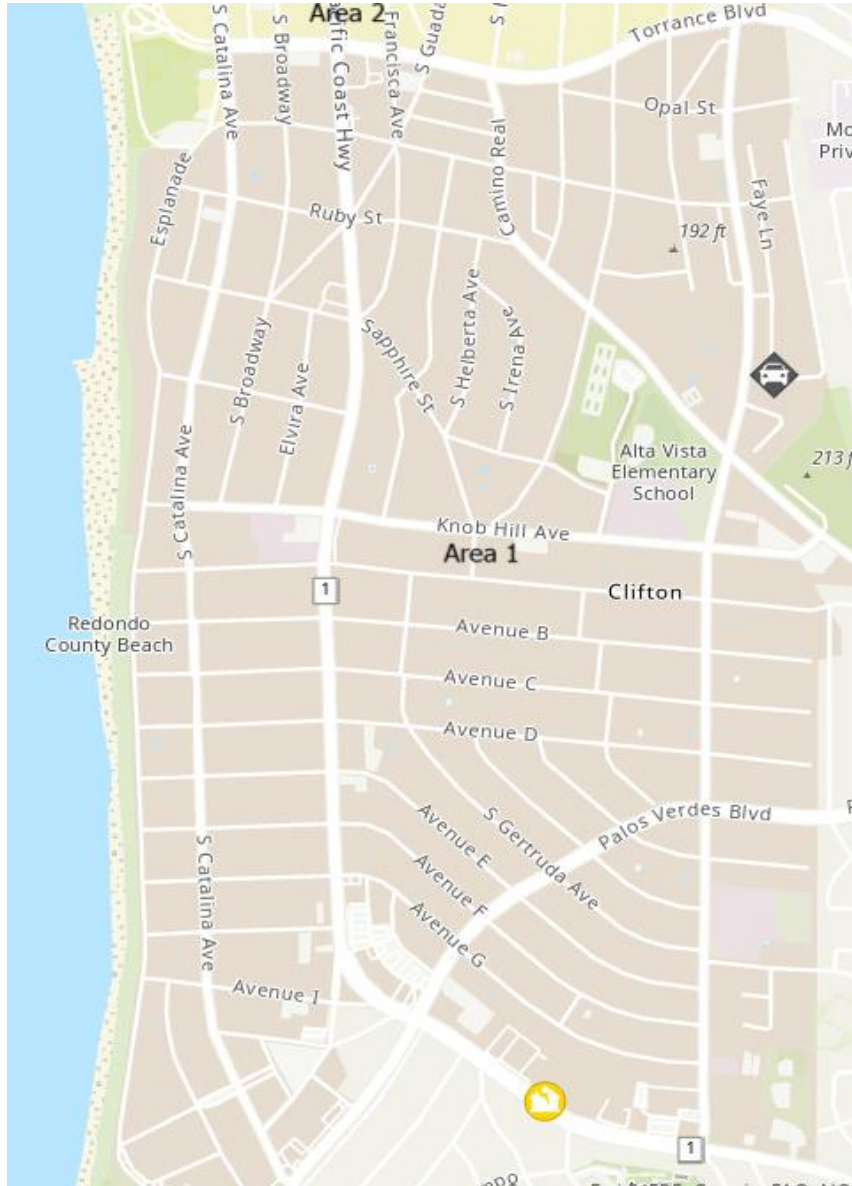
